

ORDER BELOW EXH.-1

- 1) The claimants have filed the present application for withdrawal of the awarded amount which is deposited by the Insurance Company as per the Award passed on 17.04.2026 by the this Tribunal in MACP No.61 of 2017.
- 2) According to the report of Nazir, it appears that Rs.20,00,000/- (Rupees Twenty Lac Only) stands deposited in the Tribunal.
- 3) Considering the above facts and circumstances of the case and looking to the report of Nazir, I pass the following order for payment.

-:: ORDER ::-

- (a) The Nazir is directed to pay the amount of compensation along with the interest etc. to the claimants of MACP No.61/2017 after proper identification and verification which is bifurcated in following manner.

Rs.2,80,000/-	40% amount be paid to the Claimant No (1) Amiben Karashanbhai Hathila by RTGS or NEFT in the account No.110303271506 of Canara Bank at-Dahod.
Rs.4,20,000/-	60% amount to be invested in Long Term Fixed deposit for the period of 05 (Five) Years in any nationalized bank in the name of the Claimant No (1) Amiben Karashanbhai Hathila.
Rs.1,20,000/-	40% amount be paid to the Claimant No (2) Shaileshbhai Karashanbhai Hathila by RTGS or NEFT in the account No.110303294727 of Canara Bank at-Dahod.
Rs.1,80,000/-	60% amount to be invested in Long Term Fixed deposit for the period of 05 (Five) Years in any nationalized bank in the name of the Claimant No (2) Shaileshbhai Karashanbhai Hathila
Rs.1,20,000/-	40% amount be paid to the Claimant No (3) Rajeshbhai Karashanbhai Hathila by RTGS or NEFT in the account No.110303303629 of Canara Bank at-Dahod.

Rs.1,80,000/-	60% amount to be invested in Long Term Fixed deposit for the period of 05 (Five) Years in any nationalized bank in the name of the Claimant No (3) Rajeshbhai Karashanbhai Hathila.
Rs.1,20,000/-	40% amount be paid to the Claimant No (4) Majubhai Karashanbhai Hathila by RTGS or NEFT in the account No.110303304122 of Canara Bank at-Dahod.
Rs.1,80,000/-	60% amount to be invested in Long Term Fixed deposit for the period of 05 (Five) Years in any nationalized bank in the name of the Claimant No (4) Majubhai Karashanbhai Hathila.
Rs.80,000/-	40% amount be paid to the Claimant No (5) Marachiyabhai Ganajibhai Hathila by RTGS or NEFT in the account No.41447438009 of State Bank of India at-Dahod.
Rs.1,20,000/-	60% amount to be invested in Long Term Fixed deposit for the period of 05 (Five) Years in any nationalized bank in the name of the Claimant No (5) Marachiyabhai Ganajibhai Hathila.
Rs.80,000/-	40% amount be paid to the Claimant No (6) Kaliben Marachiyabhai Hathila by RTGS or NEFT in the account No.110303316761 of Canara Bank at-Dahod.
Rs.1,20,000/-	60% amount to be invested in Long Term Fixed deposit for the period of 05 (Five) Years in any nationalized bank in the name of the Claimant No (6) Kaliben Marachiyabhai Hathila
Rs.20,00,000/-	Total Rupees Twenty Lac Only.

(b) Interest on the above said fixed deposit investment as and when it becomes due, shall be paid to the concern claimant periodically as and when it becomes due. However, they will not be entitled to withdraw any amount before maturity or raise any loan from the said investment, without prior permission of this Tribunal.

- (c) No loan or over draft or advance, known by any other name or nomenclature shall be made available on the said fixed deposit investment and the bank shall not allow any encumbrance on the said investment without prior permission of this Tribunal.
- (d) The Bank Manager shall intimate to this Tribunal the particulars of the Fixed Deposit investment such as date of investment, number of fixed deposit receipt, date of maturity etc. immediately after the issue of fixed deposit receipt.
- (e) At the end of the stipulated period of 05 (five) years as aforesaid, the bank shall pay the principal amount of the F.D.R. with interest accrued thereon, if any, directly in the savings bank account of the concern claimants.
- (f) This order alongwith copy of Ex-1 of this petition to be sent to the Nazir for necessary action.
