

MACMA No. 307 OF 2026ORDER BELOW EXH.-1

1. The claimants have filed the present application for withdrawal of the awarded amount which is deposited by the Insurance Company as per the Award passed on 05.06.2026 by the Ld. M.A.C.Tribunal (Main) in MACP No.46 of 2025.
2. According to the report of Nazir, it shows the deposit of money to the tune of Rs.20,25,000/- (Rupees Twenty Lac Twenty Five Thousand Only).
3. Considering the above facts and circumstances of the case and looking to the report of Nazir, I pass the following order for payment.

-:: O R D E R ::-

- (1) The Nazir is directed to pay the amount of compensation along with the interest etc. to the claimant after proper identification and verification which is bifurcated in following manner :-

Rs.1,62,000/-	40% amount be paid to Claimant No.(1)Badiben Rameshbhai Bhuriya by RTGS or NEFT in account No.8345060800 of Indian Bank,at-Godhra.
Rs.2,43,000/-	60% amount to be deposited in F.D.R. for a period Five Years in any Nationalized Bank in the name of the Claimant No.(1)Badiben Rameshbhai Bhuriya.
Rs.1,62,000/-	40% amount be paid to Claimant No. (2)Dashrathbhai Rameshbhai Bhuriya by RTGS or NEFT in account No.8345043400 of Indian Bank,at-Godhra.
Rs.2,43,000/-	60% amount to be deposited in F.D.R. for a period Five Years in any Nationalized Bank in the name of the Claimant No.(2)Dashrathbhai Rameshbhai Bhuriya.

Rs.4,05,000/-	100% amount to be invested in any nationalized bank in the name of the Claimant No(3)Minor Jashodaben Rameshbhai Bhuriya with the name of Claimant No (1) Badiben Rameshbhai Bhuriya as her guardian and next friend, in Long Term Fixed deposit for the period of 05 (Five) Years or the minor attains majority, whichever is latter.
Rs.4,05,000/-	100% amount to be invested in any nationalized bank in the name of the Claimant No(4)Minor Astikbhai Rameshbhai Bhuriya with the name of Claimant No (1) Badiben Rameshbhai Bhuriya as his guardian and next friend, in Long Term Fixed deposit for the period of 05 (Five) Years or the minor attains majority, whichever is latter.
Rs.4,05,000/-	100% amount to be invested in any nationalized bank in the name of the Claimant No(5)Minor Jesalbhai Rameshbhai Bhuriya with the name of Claimant No (1) Badiben Rameshbhai Bhuriya as his guardian and next friend, in Long Term Fixed deposit for the period of 05 (Five) Years or the minor attains majority, whichever is latter.
Rs.20,25,000/-	Total Rupees Twenty Lac Twenty Five Thousand Only.

(2) Interest on the above said fixed deposit investment as and when it becomes due, shall be paid to the claimant monthly or periodically as and when it becomes due. However, They will not be entitled to withdraw any amount before maturity or raise any loan from the said investment, without prior permission of this Tribunal.

(3) In case of minor claimants, the claimant No.1 the guardian of minor claimants entitled to withdraw interest monthly or periodically.

(3) No loan or over draft or advance, known by any other name or nomenclature shall be made available on the said fixed deposit investment and the bank shall not allow any encumbrance on the said investment without prior permission of this Tribunal.

(4) The Bank Manager shall intimate to this Tribunal the particulars of the Fixed Deposit investment such as date of investment, number of fixed deposit receipt, date of maturity etc. immediately after the issue of fixed deposit receipt.

(5) This order alongwith copy of Ex-1 of this petition to be sent to the Nazir for necessary action.
