ORDER

(1) The present petition under Section 7 of Guardians & Wards Act, 1890 has been filed by maternal uncle of Master Devisingh & Master Raj whose date of birth are 17.03.2011 and 08.04.2014. Tapubha Manek and Smt. Rukhabai Tapubha Manek, parents of the children had expired on 29.01.2015 and 03.05.2016. The petitioner wants to be appointed as guardian of the children for the purpose of education and welfare as well as other purposes. He has no adverse interest against the minor and is near relatives and fully and fully well wisher. The children are residing with him since death of their parents.

2. Public Notice was issued calling objection if any against the present petition but no one is appeared to contest or to file objection. In support of his case the petitioner filed his affidavit Ex. 6. The same is

3. I have gone through the material on record and heard arguments. During arguments the Ld. Advocate on behalf of petitioner stated that both minor children Master Devisingh and Master Raj are residing with the petitioner as he is maternal uncle (brother of mother of children) and petitioner wants to avail Government Help for the studies of minor. There is no other property in the name of minor.

4. The petition is allowed and petitioner Dhanabha Lakhubha Sumaniya is appointed as guardian in respect of the person and property of the minors i.e. Devisingh Tapubha Manek & Raj Tapubha Manek. The petitioner will be entitled to receive Government Help for the purpose of studies of Minor Devisingh & Raj. It is clarified that the petitioner will not be entitled to dispose of immovable property, if any, in the name of children on the basis of copy of this order. File be consigned to record room.
