With the following terms and conditions :

1. The said amount shall be invested as fixed deposit in any nationalized bank for the period of five years in F.D.R. in the name of applicant(s).
2. Without prior permission of this tribunal, the bank should not float any loan or advance against this fixed deposit as per the authority reported in 1996(3) S.C.C.-608 (Supreme Court).
3. The applicant will be entitled to get periodical interest that may accrue on the fixed deposit from time to time as per the rules of the said bank.

The Nazir is directed to paid amount through NEFT/RTGS in the account of Motor Accident Claim Tribunal (Main) Gandhinagar as per direction issued by Hon'ble Supreme Court of India W.P No 534/2020, on proper Verification.

The Nazir is directed to receive relevant documents like Aadhar Card, Pan Card, Bank pass book with photograph produced by applicant before the payment.

After verification of relevant documents produced by the Applicant and proper identification of the same the Applicant/s will/shall be given Amount of compensation as per above order.
