Criminal Misc. Application No.375 / 2026

(Order below Exh.1)

The present application has been made under Section 95 of Bharatiya Nagarik Suraksha Sanhita, 2023 seeking to have CDR (Customer Detailed Record), SDR (Subscriber Detailed Record), CAF (Customer Application Form) and certificate under section 63(4)(c) of the Bharatiya Sakshya Adhiniyam, 2023 from the service provider.

Heard learned A.P.P. The investigation is on and for the purpose of conclusion of investigation and thereafter for trial, CDR, SDR, CAF and the certificate are very much required from the said service provider in respect of the persons and their mobile numbers for time specified in the application.

The present Court has been empowered by Section 95 of the Bharatiya Nagarik Suraksha Sanhita, 2023 (Section 92 of Code of Criminal Procedure Code). In this respect the Sub Section 1 of Section 92 is material which goes as follows;

"If any document, parcel or thing In the custody of a postal or telegraph authorities, in the opinion of the District Magistrate, Chief Judicial Magistrate, Court of Session or High Court wanted for the purpose of any investigation, inquiry, trial or other proceeding under this Code, such Magistrate or Court may require the postal or telegraph authority, as the case may be, to deliver the document, parcel or thing to such person as the Magistrate or Court directs."

Exercising the power under the said sub section, the present application requires to be granted and therefore following final order is passed ;

ORDER

1. The present application is hereby Granted.
2. The service provider namely Vodafone IDEA, Reliance Jio are directed to make available CDR, SDR, CAF and certificate under Section 63(4)(c) of the Bharatiya Sakshya Adhinyam in respect of the individuals whose details are specified in the below tabular form.
