ORDER IN M.A.C.M.A. No. 133 OF 2026

(M.A.C.P. NO.326 of 2019)

(In Hon'ble High Court of Gujarat

R/F.A. No. 3514 of 2025 & R/F.A.No. 3778 of 2025)

- In view of the judgment/order passed in above claim petition, the following order is passed for disbursement of deposited amount:
- Awarded Amount : Rs.79,70,200=00.
- Date of Award : 12.06.2025.
- As per the endorsement made by Nazir, Opponent No.4 has deposited **Rs.25,000=00** [Rupees Twenty Five Thousand only] **[F.D.]** & **Rs.60,87,333=00** [Rupees Sixty Lacs Eighty Seven Thousand Three Hundred Thirty Three only] **[F.D.]**, Opponent No.4 has deposited amount of **Rs.25,000=00** [Rupees Twenty Five Thousand only] **[F.D.]** & **Rs.60,89,801=00** [Rupees Sixty Lacs Eighty Nine Thousand Eight Hundred One only] **[F.D.]** in the court. [All FDRs are in the name of Nazir]
- After release of above FDRs, as per the endorsement made by Nazir : amount of **Rs.1,22,41,571=00** [Rupees One Crore Twenty Two Lacs Forty One Thousand Five Hundred Seventy One only] deposited in the Court.

- Endorsement made by Insurance Companies.

NOTE : Applicant No.1 is the natural guardian & next friend of Applicant No.2 [MINOR].

With the following terms and conditions :

1. The said amount shall be invested as fixed deposit in any nationalized bank for a period of five years in favour of applicant(s) and same shall be renewed from time to time and shall not be encashed till final disposal of the appeal.
2. Without prior permission of this tribunal, the bank should not float any loan or advance or encashment against this fixed deposit as per the authority reported in 1996(3) S.C.C.-608 (Supreme Court).

3. The Original FDRs be retained by the Nazir Department of the concerned Tribunal.
4. The fixed deposit amount shall be renewed every five years or till the minor attains the age of majority or final disposal of appeal , whichever is later.

The Nazir is directed to pay amount through NEFT/RTGS from the account of Motor Accident Claim Tribunal (Main) Gandhinagar as per direction issued by Hon'ble Supreme Court of India W.P. No. 534/2020, on proper verification.

The Nazir is directed to receive relevant documents like Aadhar Card, Pan Card, Bank pass book with photograph from applicant at the time of payment.

After verification of relevant documents produced by the Applicant and proper identification of the same the Applicant/s will/shall be paid the Amount of compensation as per above conditions.
