

THE MOTOR ACCIDENT CLAIM TRIBUNAL [AUXI - III] GANDHINAGAR
ORDER BELOW THE M.A.C.M.A. NO.250 of 2026
(M.A.C.P. No.20 OF 2010)

- In view of the judgment/order passed in above claim petition, the following order is passed for disbursement of the deposited amount:78,600=00
- Date of Award :28-02-2018
- The opponent has deposited through NEFT/RTGS through MACP Register No.339 On Dt.04/02/26, **Rs.1,76,572=00 [Rupees One Lakh Seventy Six Thousand Five Hundred Seventy Two Only]** in the court.
- Deficit Court fees stamp of **Rs.2980/-** to be deducted.
- Total Amount after fees stamp of **Rs.1,73,592/-**
- Other side has No Objection for Payment and no appeal or stay is pending in connection with case.
- **As per the Hon'ble M.A.C.T (AUXI-III), Gandhiangar order, (i)** After the amount is deposited by the opponent No.1 to 3, the amount is ordered to be disbursed to the applicant. It is further directed that the entire amount to the extent of share of the applicant concerned, 30% of the awarded amount is ordered to be paid by an account payee cheque and 70% of the awarded amount is ordered to be invested in fixed deposit in the name of the applicant for a period of 5 years in any Nationalized Bank, situated in the town where applicant resides. The Bank shall take note that the Fixed Deposit should be opened only in the name of applicant with no joint applicant except near relative. The said investment shall carry the following terms and conditions.

With the following terms and conditions :

1. The said amount shall be invested as fixed deposit in any nationalized bank for the period of five years in F.D.R. in the name of Applicants.
2. Without prior permission of this tribunal, the bank should not float any loan or advance against this fixed deposit as per the authority reported in 1996(3) S.C.C.-608 (Supreme Court).
3. *The applicant will be entitled to get periodical interest that may accrue on the fixed deposit from time to time as per the rules of the said bank.*

The Nazir is directed to paid amount through NEFT/RTGS in the account of Motor Accident Claim Tribunal (Main) Gandhinagar as per direction issued by Hon'ble Supreme Court of India W.P. No. 534/2020, on proper Verification.

The Nazir is directed to receive relevant documents like Aadhar Card, Pan Card, Bank pass book with photograph produced by applicant before the payment.

After verification of relevant documents produced by the Applicant and proper identification of the same the Applicant/s will/shall be given Amount of compensation as per above order.
