1. Present application has been given by the applicants to withdraw the amount of compensation which is deposited in the Tribunal in respect of aforesaid MACP.
2. Heard Ld. Advocate for the applicants and perused the copy of award.
3. As per report of Nazir following amount of fixed deposit has been deposited in respect of aforesaid MACP.

4. As per the endorsement of the Dy. Registrar MACT (Main), Dist. Gir-Somnath, no any appeal is pending before the Hon’ble High Court against the award passed by this court in the said MACP and at the time of encashment of fixed deposit on dated 11.03.2026, Civil “C” Register Receipt No. 66 / 25-26, Rs. 63,328/- received with interest from the Bank.

5. The Tribunal passed the award in the favour of heirs of Deceased Babubhai Nanaji Nakum. The present applicant no.3 has produced the Pursis for her identification at Exh. 5. It is stated that at the time of award her name is Asmitaben Babubhai Nakum. The said name is mentioned in the award at the time of unmarried life and mentioned her father name Babubhai Nakum. After that she is married with Katariya Mukeshbhai and after that she has mentioned her full name Asmitaben Mukeshbhai Katariya. For that she has produced her Aadhar Card at Mark 3/6 and her Bank cheque at Mark 3/7 in which her name is Asmitaben Mukeshbhai Katariya. After that she has also produced her school leaving certificate at Mark 6/1 in which her name is Asmitaben Babubhai Nakum and she has also produced the cancelled cheque at Mark 6/2 in which her name is Asmitaben Mukeshbhai Katariya. Therefore, It shows that the present applicant no.3 Asmitaben Babubhai Nakum and Asmitaben Mukeshbhai Katariya is the same person. Hence, it is required to pay the amount in the name of Asmitaben Mukeshbhai Katariya.
  
6. Considering the award as well as report of Nazir and report of the Dy. Registrar MACT (Main), Gir Somnath, I pass following order:-

**// ORDER //**

1. Application is allowed.
2. Concerned authority is directed to release the fixed deposit amount of **Rs. 61,178/- with interest (after deducting court fee of Rs. 2150/- from Rs. 63,328/-)** which is deposited in the name of Nazir of this Tribunal and ordered to disburse the said amount with interest to the heirs of Deceased Babubhai Nanji Nakum as follows :
