

**ORDER BELOW EXHIBIT : 1 (PAYMENT ORDER)****IN****MA-CMA NO. 21/2026 [ MACP No. 1009/1999 ]**

1. Present application has been given by the applicants to withdraw the amount of compensation which is deposited in the Tribunal in respect of aforesaid MACP.
  2. Heard Ld. Advocate for the applicants and perused the copy of award.
  3. As per report of Nazir following amount of fixed deposit has been deposited in respect of aforesaid MACP.

4. As per the endorsement of the Dy. Registrar MACT (Main), Dist. Gir-Somnath, no any appeal is pending before the Hon’ble High Court against the award passed by this court in the said MACP and at the time of encashment of fixed deposit on dated 08.04.2026, Civil “C” Register Receipt No. 05 / 26-27, Rs. 26,327/- received with interest from the Bank.

5. The Tribunal passed the award in the favour of Deceased Vijiyaben Mohanbhai Anjani. Therefore, applicant has produced death certificate and pedigree of Deceased Vijiyaben Mohanbhai Anjani at Mark 3/1 and 3/2. But, the applicant no.1 named Shardaben Mohanbhai Anjani has also died on 31.12.2024 as per death certificate produced at Mark 3/3 and also produced pedigree of Deceased Shardaben Mohanbhai Anjani at Mark 3/4. Therefore, it is required to pay compensation amount in the name of legal heirs of Deceased Shardaben Mohanbhai Anjani and other applicants.
6. Considering the award as well as report of Nazir and report of the Dy. Registrar MACT (Main), Gir Somnath, I pass following order:-

**// ORDER //**

1. Application is allowed.
2. Concerned authority is directed to release the fixed deposit amount of **Rs. 25,661/- with interest ( after deducting court fee of Rs. 666/- from Rs.26,327/- )** which is deposited in the name of Nazir of this Tribunal and ordered to disbursed the said amount with interest in their bank account through NEFT/RTGS to the heirs of Deceased Kanakben Himatlal Sagar as follows :
