

ORDER BELOW EXHIBIT : 1 [PAYMENT ORDER]**IN****MA-CMA NO. 26 OF 2026 (MACP NO : 1173/1999)**

1. Heard Ld. Advocate for the applicants and perused the copy of award.
2. Present application has been given by the legal heirs of Deceased Aminaben Abbasbhai Basathiya to withdraw the amount of compensation which is deposited in the Tribunal in respect of aforesaid MACP. After passing the order dated 30.03.2012, the applicant Aminaben Abbasbhai Basathiya was expired on 10.06.2013 as per the death certificate produced at Mark-3/3. And also One of her legal heir named Yunusbhai Abbasbhai Basathiya was expired on 13.06.2021 as per the death certificate produced at Mark-3/5. Therefore, along with other applicants, legal heirs of the applicant filed this application with pedigree of the Late Aminaben Abbasbhai Basathiya produced at Mark-3/1 and pedigree of the Late Yunusbhai Abbasbhai Basathiya produced at 3/2. As per pedigree, present applicants are the legal heir of the Late applicant Aminaben Abbasbhai Basathiya, hence, they are entitled for receiving the amount of compensation deposited in this tribunal.
3. As per report of Nazir following amount of fixed deposit has been released in respect of aforesaid MACP.
