J U D G M E N T

Particulars of offence read over and explained to accused in vernacular. He pleads guilty. Consequence of his plea and punishment that may be imposed on him again explained to him. Still he pleads guilty. I found his plea to be voluntary one. Hence, I held him guilty for offence under section 285 of the BNS. I take pause to hear the accused on the point of sentence. He submit that, he is poor and only earning member of his family, so leniency may be shown to him and kindly requested to award minimum & lessor punishment. Considering the nature of offence and submissions made by accused, I think following sentence will meet the ends of justice. Hence, I proceed to pass the following order:-

O R D E R

- 1] Accused namely, **Subhash Gobriji Gharpinde** is convicted for the offence under section 285 of the Bharatiya Nyaya Sanhita, 2023 vide section 275 of the Bharatiya Nagarik Suraksha Sanhita, 2023.
- 2] On the first count he is sentenced to pay a fine of Rs. 1,000/- (Rs. One Thousand Only) in default to suffer simple imprisonment for Five (05) days.
- 3] Fine amount of Rs. 1,000/- (Rs. One Thousand Only) be credited to Government.
