ORDER BELOW EXH. 04

1] This is an application by applicant Sunny Devala Meghawat to release his Bajaj Pulsar 125 motorcycle bearing registration No. MH-12-UD-0568, Engine No. JEXCNM31661 and Chassis No. MD2B72BX9N CM08930 on Supratnama, which is seized by Bharti Vidyapeeth police station in CR No. 762/2022 registered under Section 363, 376, 376 (2)(j) of Indian Penal Code.

2] IO submitted report at Exh. 08 and submitted no objection to release the vehicle in favour of applicant.

3] Heard the applicant and Ld. APP. Applicant tendered his pan card and RTO smart card. From those documents the identity of the applicant is established and the smart card also disclosed that the present applicant is the registered owner of this two wheeler. The vehicle is seized from Tushar Meghawat, the brother of the applicant. He is present before me and he submitted no objection to hand over this vehicle to the applicant. For all these reasons, I hold that applicant is entitled for interim custody of this vehicle on certain conditions. Hence, the order :-

ORDER

1] Application is allowed.

- 2] Bajaj Pulsar 125 bearing registration No. MH-12-UD-0568 seized in CR No. 762/2022 of Bharti Vidyapeeth Police Station registered under Section Section 363, 376, 376(2) (j) of Indian Penal Code, be released in favour of the applicant **Sunny Devala Meghawat** on his executing supratnama bond of **Rs. 1,50,000/- (Rs. One Lakh Fifty Thousand only)** containing following conditions -
- a] The applicant shall not change the nature and identity of this vehicle nor shall pledge, sell or dispose of this vehicle to any other person without prior permission of this court.
 - b] The applicant shall produce this vehicle as and when called by the Court.
 - c] If at the time of final disposal of this case applicant is not found to be the registered owner of this car he shall pay **Rs. 1,50,000/- (Rs. One Lakh Fifty Thousand only)** to its real owner.
- 3] The investigating officer is directed to take the photographs of this vehicle from all angles and submit the same in charge-sheet. Only after taking photographs the vehicle shall be delivered to applicant.
- 4] Supratnama be executed before this Court.
- 5] On execution of Supratnama bond and on compliance of directions in clause (3) of this order, the above said vehicle be handed over to applicant **Sunny Devala Meghawat** on verification of his vehicle papers and identity.
