The State of Tripura Vs. Sujan Miah & Ors.

Ld. APP in-charge is present.

Eight accused persons namely **Ripan Miah, Rubel Miah S/o-Malu Miah, Sakir Hossain, Sujan Miah @ Mithun, Arif Miah, Dulal Miah, Rubel Miah @ Banka, S/o- Ramjan Ali and Sarif Hossain** are produced before the Court on remand from J/C through VC.

Ld. Counsel Mr. M. Kr. Saha is present for the accused **Dulal Miah** and by filling a bail petition has prayed for releasing the accused person on bail on any condition.

Ld. Counsel Mr. F. Haque is present for accused **Sakir Hossain** and by filling a bail petition has prayed for releasing the accused on bail on any condition.

Ld. Counsel Mr. A Khoyer is present for the accused **Sarif Hossain** and by filling a bail petition has prayed for releasing the accused person on bail on any condition.

Heard both sides on the point of bail.

Ld. APP in-charge has strongly opposed the bail applications.

Considering the nature and gravity of the offence and the fact that the offences are exclusively triable by the Court of Session, I am of the opinion that it would not be proper to release the accused persons on bail at this stage.

Hence, the bail petition on behalf of the accused persons namely Dulal Miah, Sakir Hossain and Sarif Hossain stands rejected at this stage and they are further remanded to J/C till 10-04-2026.

Accused **Aiachin Miah** is present with his engaged counsel Mr. J. Uddin on completion of interim bail period.

He is taken into custody.

A petition is filed on his behalf for extension of his interim bail.

Prayer is allowed.

The accused is allowed to stay on interim bail till 10-04-2026 on strength of previous bail bond.

Ld. Dy. LADC Sri S. Islam has filed hajira on behalf of the five accused persons namely **Arif Miah, Sujan Miah @ Mithun, Rubel Miah** S/o- Malu Miah, **Rubel Miah** S/o- Ramjan Ali and **Ripan Miah**, who are in J/C.

Ld. Counsel Ms. P. Das is present for the accused Rubel Miah.

As no bail prayer is filed for the above named accused persons, so they are remanded to J/C till **17-04-2026**.

Accused persons namely, Sagar Miah, Khokan Miah and Aziz Miah are not present today even though

proclamation was issued against them.

Warrant of attachment of the properties of the accused persons namely, Sagar Miah, Khokan Miah and Aziz Miah in compliance with Section 85 of BNSS has not returned with or without execution till date.

By filing a petition, the O/C, Sonamura PS has prayed for allowing further time to ascertain whether there is any immovable property in the name of the accused persons. It is further mentioned that no movable property belonging to the accused persons could be found.

Considered the report.

O/C, Sonamura PS is directed to ensure immediate compliance of the order dated 31.03.2026 and to execute the warrant of attachment issued against the accused persons as early as possible.

Inform accordingly.

Received fingerprint examination report from the O/C, Sonamura PS along with a prayer to tag it with the judicial and police docket.

Supply a copy of this report to all the accused persons.

Fix **17/04/2026** for remand/surrender/report of attachment/further order.
