- (1). The Applicants are being maternal grand-father (minor's mother's father) and minor's father's maternal uncle of the minor Hidansh aged about 4 years. The Ld. Advocate for the Applicants Mr. M.M. Kubavat for the Applicants has filed pursis at Exh.-16 declaring that the child is staying with Applicant No.1 / grandfather and if the Applicant No.1 only is appointment as guardian, then it will serve the purpose.
- (2). Heard the Ld. Advocate Mr. M. M. Kubavat for the Applicants and also gone through the affidavits of the Applicants at Exh.-8 and Exh.-9 and also through the documents at Exh.-11 to 14.
- (3). The Applicant No.1 and 2 have filed the affidavit at Exh.-8 and 9 and stated that the father and mother of the minor Hidansh are expired and the property at Exh.-13 is in the name of the parents and grand-mother of minor, but the parents have expired. They are required to appoint the guardian and obtain the guardian for education purpose and other purpose. It reveals from Exh.-11 and Exh.-12 that the parents of the minor have expired. The death certificate of the minor is produced at Exh.-13. The sale deed of the properties is produced at Exh.-14. Looking the oral and documentary evidence on record in the Court, it will be in the welfare of the child to appoint the Applicant No.1 - Damji Naranbhai Katarmal as a guardian of minor grandson Hidansh and accordingly, I pass the following order:

**:: ORDER ::**

- **The Applicant No.1 - Damjibhai Naranbhai Katarmal is appointed as a guardian of his minor grandson - Hidansh, for the purpose of managing all**

**educational activity of the child to manage the property. It is made clear that the guardian will have right to do all other activities in the welfare of child, except selling, mortgaging, gifting, leasing or transferring in any manner any of the immovable property of the minor child Hidansh or property which where in the name of his parents - mother and father, which can be inherited by him.**

- The Guardianship certificate can be used for educational purpose, bank accounts opening, getting property transferred in the name of minor etc., except as restricted above.**
- No order as to cost.**
