The M.A.C.P. No.199 of 2015 has been filed by the petitioner **Kamleshbhai Ramniklal Parekh** under Section 166 of the Motor Vehicle Act seeking compensation and which came to be partly allowed. As per the order of Tribunal, the Opponent Insurance Co. deposited amount of compensation before District Court, Nazir- Jamnagar.

Thereafter, Opponent - Insurance Co. Ltd challenged the order of Tribunal before Hon'ble High Court of Gujarat vide **R/First Appeal 3753 of 2025 with Civil Application (For Stay) No.1 of 2025 in R/First Appeal No.3753 of 2025** and which has been dismissed by the Hon'ble High Court of Gujarat wherein the Hon'ble High Court of Gujarat held that "*R & P, if any, to be sent back to the concerned Court immediately. The entire award amount be disbursed and released in favour of claimant/s after due verification by transferring said amount/s to the account/s of claimant/s by RTGS or NEFT.*"

(2) The applicant has supported to his say by producing Copy of writ order of R/First Appeal No.3753 of 2025, Copy of Aadhar Card, Copy of PAN Card and Copy of Bank-Pass Book of applicant.

(3) Read the claim amount withdrawal application and

endorsement made by the opponent's advocate on the claim amount withdrawal application and the endorsement made by the concern branch of District Court, Jamnagar.

As per the endorsement made by the Nazir, District Court, Jamnagar **Rs.20,750/-** has already been deducted towards court fees vide D Reg No.470 dated 10.09.2025.

After considering all the factors and order passed by the Hon'ble High Court in ***R/First Appeal No.3753 of 2025***, I pass the final order for the disbursement of the award amount as follow.

FINAL ORDER

That the amount of **Rs.11,50,938/-** is disbursed to applicant as under. :--

Rs.11,50,938/- Rs. Eleven Lakh Fifty Thousand Nine Hundred Thirty Eight Only.

Kamleshkumar Ramniklal Parekh

by Account payee cheque or by direct transfer to the credit of bank account of claimant by NEFT or RTGS after proper confirmation and verification.

Rs.11,50,938/- = Total Rupees Eleven Lakh Fifty Thousand Nine Hundred Thirty Eight Only.
