

ORDER BELOW EX.1

- (1) The applicant has preferred present application for withdrawal of the amount invested as Fixed Deposit Receipt which has been awarded to her as compensation being the applicant of MACP No. 327 of 2013. Accordingly, the Opponents - Insurance Companies have deposited the amount of compensation before District Court, Nazir-Jamnagar which is lying in form of FDR in the name of claimant in safe custody with Nazir, District Court – Jamnagar vide Custody No.5666 and 5970. Thereafter, the Opponent No.4 - Insurance Co. Ltd challenged the order of Tribunal before Hon'ble High Court of Gujarat vide **R/First Appeal No. 3748 of 2025** which has been dismissed by the Hon'ble High Court of Gujarat on dated 13.04.2026 and wherein the Hon'ble High Court had held as under;

“R & P, if any, to be sent back to the concerned Court immediately. The entire award amount be disbursed and released in favour of claimant/s after due verification by transferring said amount/s to the account/s of claimant/s by RTGS or NEFT.

Now, the applicant herein has preferred the present application for withdrawal of the amount which has been kept in Fixed Deposit with the Nazir of the District Court alongwith a copy of said R/First Appeal No. 3748 of 2025. As per the endorsement of the Nazir dated 21/05/2026, the amount lying with the Nazir is Rs.9,78,308/- and an amount of Rs.17,150/- has already been recovered towards the Court Fees stamps and therefore, the aforesaid amount of Rs.9,78,308/- be disbursed to the applicant as per the bank details, PAN and Aadhar details disclosed by the applicant are as under:-
