

ORDER BELOW PAYMENT PURSIS**(M.A.C.M.A.NO. 225 of 2026)****IN****Motor Accident Claim Petition bearing No. 125 of 2020.****Read:-**

- 1) Judgment and award being dated 10/04/2026.
- 2) Endorsement carried-out by the Learned Advocate for the opponent No.4 – The National Insurance Co. Ltd. stating that they have no objection if amount is paid as per the direction of the Tribunal, as neither appeal being preferred nor stayed judgment and award of the Tribunal.
- 3) Report of the Nazir, District Court Jamnagar stating the amount having been deposited in the Court by the opponent No.4- The Natonal Insurance Co. Ltd.
- 4) The said amount which was deposited was kept in Fixed Deposit by the Nazir of the District Court. As per the Report of the Nazir dated 12/06/2026, the amount deposited by the Opponent No.4- Insurance Company lying with the Nazir is Rs.6,16,000/-. Out of deposited amount of Rs.6,16,000/-, an amount of Rs.15,000/- has already been recovered towards the Court Fees stamps from the amount deposited by the opponent No.2 of the aforesaid MACP No.125 2020 in MACMA No.193 of 2026 filed by the applicants. Therefore, the said amount of Rs.6,16,000/- deposited by the opponent No.4 – Insurance Company be disbursed to the
