3. A report from SHO P.S. City-I, Abohar received and perused.
ASI Darshan Singh No. 210/Fazilka P.S. City-I, Abohar got recorded his
separate statement to the effect that Paramjit Kaur wife of Lachhman Singh
resident of village Ghall Kalan Tehsil & District Moga is required in case
FIR no. 291 dated 31.10.2022 under sections 346, 120-B IPC P.S. City-I,
Abohar. He further stated that vide DDR no. 21 dated 11.11.2022, offences
under sections 370, 370-A IPC were enhanced in this case and offences
under sections 346, 120-B IPC were reduced in this FIR. Applicant
Paramjit Kaur and Sarabjit Kaur were nominated as accused in this case

and custodial interrogation of applicant is required.

4. Keeping in view the aforementioned report made by SHO P.S. City-I, Abohar coupled with the statement of ASI Darshan Singh, since the name of applicant Paramjit Kaur has already been nominated in FIR no. 291 dated 31.10.2022, referred to above, the present application seeking blanket bail has become infructuous and the same is hereby ordered to be dismissed, being infructuous.
