:- ORDER :-

- (1) Herein, MACP No.209/2019 has been decided by way of Judgment and Award dated 09.03.2026 and concerned the opponent has deposited the amount. Therefore, applicant has preferred present application to withdraw the deposited amount of award.
- (2) At the time of passing the Award, the Tribunal has passed the following order:
 - “(5) The all interim orders shall merge into final order.
 - (6) If any amount is paid U/s. 140 of the Motor Vehicles Act,1988 then that amount shall be deducted from the awarded amount.
 - (7) Under section 168(3) of the Motor Vehicles Act, 1988,

opponent No. 3-insurer shall deposit the awarded amount with interest, as held above, within 30 days from the date of this order.

(8) Nazir is hereby directed to deduct the amount of court fee if it is leviable from the claimant.

(9) The order as regard disbursement be made at the time of withdrawal of amount.”

(3) This Tribunal has passed following order at Exh.1:-

“The applicant/applicants shall furnish following information immediately :-

1. Whether appeal has been preferred by either party?
2. Whether any stay order against execution of award of the Higher Court is there?

And further the Senior Clerk, M.A.C.T. Branch shall have endorsement of person concerned that whether any writ for filing of appeal has been received in this matter and whether any stay against execution of award is there or not ?”

(4) Thereafter, the concerned Clerk has made an endorsement on 10.07.2026 that no writ of the Hon'ble High Court is received since 05.03.2026 and it reveals that there is no any stay so far as present MACP is concerned and same time, statement has been made in the petition that no appeal or revision has been preferred against the Judgment by the opponent insurer before the Hon'ble Higher Court and no notice or summons of the same is served upon the applicant.

(5) The Advocate of the other side has made endorsement of ‘No Objection to payment of the amount of compensation’.

(6) The Nazir has endorsed on 17.07.2026 that amount of Rs.3,12,733/- stands credited in this petition vide “C” No.92 dated 16.07.2026. Nazir has further endorsed that earlier no Court Fees has been deducted.

- (7) Therefore, considering that the amount and age of the applicant, it would be just and proper that the **entire amount** be disbursed in **cash** in favour of the applicant.
- (8) Therefore, in view of the above, the following disbursement order is passed and the present application stands disposed off accordingly.
