:: J U D G M E N T ::

1. This application is preferred by the applicant/accused person under section 483 of the Bhartiya Nagarik Suraksha Sanhita, 2023 for releasing him on regular bail. Earlier the applicant/accused was enlarged on bail. Then-after, he was taken into judicial custody on 25/05/2026, again in POCSO Case No. 04 of 2022, vide Cr.- Register No. First-16/2017, Mangrol Police Station, as he breached the condition of bail.
2. Heard Ld. Advocate appearing for the applicant/accused person and Ld. APP appearing for the Opponent State.
3. Having regard to the facts of this case, in order to decide this regular bail application u/S. 483 of the B.N.S.S.,2023, established principles as to bail have been taken into consideration. The applicant/accused was taken into judicial custody for breach of condition of bail bond. Now, Ld. Advocate for the accused has assured this Court that the applicant/accused shall remain present invariably at time and date fixed by the Court. Considering the averments and assurance of Ld Pleader, it would be just to grant bail to the applicant/accused and I, therefore, pass the following order.

This Criminal Misc. (Reg. Bail) Application No. 210 of 2026 stands **allowed**.

The **applicant/accused person- Pavan Harsukhbhai Kharva**, of Criminal Misc.(Reg. Bail) Application No.210 of 2026, residents of the address shown in the cause title is hereby **released on bail on furnishing personal bond of Rs.10,000/- and one surety of like amount for the applicant**, subject to remain present invariably during the trial in the Court.

Bail is to be given before the concerned Court where judicial proceeding is pending.
