-: J U D G M E N T :-

1. The applicant has preferred the present application for withdrawal of the amount deposited pursuant to the Award dated 18/09/2025 passed in MACP No.254/2018. The applicant has also produced list of documents along with supporting documents with this application.
2. The present matter is kept for hearing and Ld.Advocate for the opponent GSRTC, Mr.P.M.Hirpara made a no objection endorsement below Exh.1.
3. As per the endorsement, initially an amount of Rs.55,793/- has been deposited in this Tribunal. Which was invested in Fixed Deposit and the said fixed deposit is released and after releasing of Fixed Deposit an Amount of Rs.56,452/- is credited vide Civil "C" register no. 30/25-26, dated 13/03/2026, ledger no. 118 in the account of this Tribunal.
4. The applicant of the present application is the original claimant in the claim petition, who sustained injuries in the vehicular accident in question. As per the award, it has been directed that 30% of the deposited amount shall be released to the claimant, while the remaining 70% shall be invested in a Fixed Deposit with any nationalized bank for a period of five years in the name of the applicant. Accordingly, the following final order is passed in the interest of justice.

-:: ORDER::-

1. The present application is hereby **ALLOWED**.
2. The deposited amount of Rs.56,452/- is ordered to be disbursed as under:-
 - (1) Out of the above total amount Rs.2,760/- be recovered first towards deficit Court Fees and credited into Govt. Treasury.
 - (2) Out of the remaining amount of Rs.53,692/-, **30%, i.e., Rs.16,108/- (Rupees Sixteen Thousand One Hundred Eight Only)**, is directed to be paid to the applicant, **Jentibhai Amrabahi Katariya**, through crossed Account Payee Cheque after due verification. The remaining **70%, i.e., Rs.37,584/- (Rupees Thirty Seven Thousand Five Hundred Eighty Four only)**, shall be invested in a Fixed Deposit in any nationalized bank of applicant's choice, in the name of the applicant, **Jentibhai Amrabahi Katariya**, for a period of five years.

The said investments in F.D. shall carry the following terms and conditions :-

- a) The applicant will be entitled to receive monthly or periodical interest on this Fixed Deposit.

- b) The bank is directed to ensure that No loan or advance will be granted on above Fixed Deposits and not to create any encumbrance against the said F.D. without prior permission of this Tribunal.

3. Yadi of this order be made to the Nazir of this Court.
