- (1) By way of this order this Tribunal shall dispose of application made by applicant **Rekhaben Vijaysinh Rathod & others** for releasing the awarded amount which has been deposited by the opponent/insurance company in **MACP No.199/2014** decided on **09/01/2023**.
- (2) As per office report opponent/insurance company deposited the amount of **Rs.17,37,136/-** vide **C.R.No. :462 Dtd : 31/05/2025** & **Rs.76,886/-** vide **C.R.No. :737 Dtd : 07/08/2025**.
- (3) The Counsel for opponent/insurance company made has endorsement on the application itself regarding “No Objection” for releasing the amount as per the award.
- (4) Applicant No. 4 has passed away and his legal heirs have relinquished their share in favour of applicant no.1, as per affidavit produced by the parties.

It is further ordered that out of the said amount, **Rs.12,250/-** be deducted towards payment of deficit court fee stamp and the same be credited to the Government.
