- (1) By way of this order this Tribunal shall dispose of application made by applicants Venugopal Rameshchandra Brahmbhatt & others for releasing the awarded amount which has been deposited by the opponent/insurance company in MACP No.588/2017 decided on 28/02/2024.
- (2) As per office report opponent/insurance company has deposited the amount **Rs.27,137/- vide C.R.No. : 1496 Dtd : 27/11/2025, Rs.1,24,653/- vide C.R.No. : 1498 Dtd : 27/11/2025 & Rs.16,02,250/- vide C.R.No. : 1499 Dtd : 27/11/2025.**
- (3) The Counsel for opponent/insurance company made has endorsement on the application itself regarding “No Objection” for releasing the amount as per the award, and she has also moved pursis for releasing 40% amount of the award to the applicants & rest of the amount with the Nazir in the shape of Fixed Deposits.

As per the order of Hon'ble High Court of Gujarat passed in F.A. No.891 of 2025, Dt.04/09/2025 the Original Fixed Deposit Receipt of 60% amount Shall be kept in the custody of the Nazir of the Tribunal which shall be renewed from time to time till the final disposal of the appeal in Hon'ble High Court and interest on such Fixed Deposit shall be paid to the Claimants periodically.

The aforesaid calculation shall be firstly checked properly by the Supeintendent and Deputy Registrar of MACP Branch, Nadiad and then shall be released after due verification and proper identification of the applicant at the time of payment.

The Bank is directed not to give any loan or advance on the aforesaid F.D.R. without prior permission of the Tribunal. However, the Bank is directed to pay periodical interest which occurs on the amount of said F.D.R. Nazir to act accordingly.

It is further ordered that out of the said amount, **Rs.5500/-** be deducted towards payment of deficit court fee stamp and the same be credited to the Government
