

CIVIL MISC. APPLICATION NO. 50 OF 2025
(IN L.A.R. CASE NO. 02/2017)
ORDER BELOW EXH. 01

- 1) Read the application and heard the learned advocate for the applicants.
- 2) The present application has been preferred by the applicants to bring the legal heirs/legal representatives of the deceased – original claimant Named **Thakor Baluben Amratji in L.A.R. No. 02/2017** under order 22, Rule 4 of Code of Civil Procedure. It is averred by the present applicants that original applicant – deceased Named **Thakor Baluben Amratji** had filed **L.A.R. No.02/2017** to get compensation and, therefore, legal heirs of deceased Named **Thakor Baluben Amratji (died on 23/05/2023)** are as follows:-

- (1) **Thakor Kesarben Amratji**
- (2) **Thakor Santokben Amratji**
- (3) **Thakor Kokilaben Amratji**
- (4) **Thakor Chandanji Amratji**
- (5) **Thakor Rameshji Amratji**
- (6) **Thakor Kapilaben Amratji**
- (7) **Thakor Nareshji Amratji**

all are resident of Village Bokarvada, Ta: Visnagar are required to bring on record of L.A.R. Case No.02/2017. It has been prayed that original applicant – deceased Named **Thakor Baluben Amratji** has died on **23/05/2023**, and, therefore, present application to join his legal

representatives as necessary parties in L.A.R. case No. **02/2017** and prayed to allow the present application.

- 3) In support of application, applicants have produced copy of death certificate of Thakor Baluben Amratji vide mark 4/1, pedigree of Thakor Baluben Amratji vide mark 4/2, copy of the Judgment passed by the Hon'ble Court in the case bearing No.LAR/02/2017 vide mark 4/3.
- 4) On presentation of the present application, this Court has issued summons to the opposents. On behalf of opponents, learned A.G.P. appeared and filed the Hazri Pursis and made endorsement below Exh. 1 and stated that, 'verifying the record, he has no objection to join the heirs of deceased'.
- 5) Considering the records and the documents produced by the applicants and heard the learned advocates at length.
- 6) In the case of Patel Kashuben Narottambhai & Anr. Vs. Special Land Acquisition Officer, Ahmedabad & Anr. reported in 2009(1) G.L.R. Page No. 1421, wherein Land Acquisition Act, Section 18, held, 'when it is brought to the notice of reference Court, even after declaration of award, that claimants- applicants have died during pendency of reference case, the Court required to treat it as an application with prayer for bringing heir on record. Provisions of Order 22 of C.P.C. and of Limitation Act apply to bringing on record heir/s of deceased, it is a tool/handmade for doing substantial justice.

- 7) Considering the records and documents produced by the applicants and endorsement made by the learned A.G.P. for opponents below Exh. 1 and principle laid down by the Hon'ble High Court, the present application is required to be allowed and hence, I pass order below Exh. 1 as follows:

//ORDER //

- 1) The application is hereby allowed.
- 2) Office is hereby directed to bring the legal heirs of **Thakor Baluben Amratji (since deceased)** namely **(1) Thakor Kesarben Amratji, (2) Thakor Santokben Amratji, (3) Thakor Kokilaben Amratji, (4) Thakor Chandanji Amartji, (5) Thakor Rameshji Amratji, (6) Thakor Kapilaben Amratji, (7) Thakor Nareshji Amratji, all are resident of Village Bokarvada, Ta: Visnagar** on record. Registry is directed to show the named in the L.A.R. Case No. **02/2017** as prayed for.
- 3) Also copy of order be placed with the L.A.R. No. 02/2017.
