

ORDER BELOW EXHIBIT-6

1) Read this application, perused the record. Heard the Ld. Adv. for the applicant (original plaintiff) as well as respondent (Original defendant).

2) The Ld. Advocate for the applicant (original plaintiff) has filed the present application for local investigation of the subject matter of the suit i.e. land having Revenue Survey No. 92 paiki 714,2-32-70 prati are, Revenue Survey No. 95 paiki 1 khata no. 715,2-32-74 prati are, Revenue Survey No. 95 paiki/2 paiki khata no. 716,2-36-74 prati are situated at Village:Ratabhe, Ta.Halvad District. Morbi That the applicant's father viz. Koli Chaganbhai Ganeshbhai had purchased the suit land in the year 2010 and the same has been registered in the revenue record and the suit land, was possessed by the plaintiff's father and after his demise, the plaintiff's mother and five sisters has got the suit land and so on, the plaintiff are having possession over the suit property. In the suit property the defendant without any right, title or interest over the suit land, has disturbed the peaceful possession over the suit property and stopped the plaintiff for doing such act over the suit property. Therefore, it is necessary to bring on the record the latest position and exact location/map of the land in question and hence, filed the

present application for appointment of Commissioner for inspection and measurement of suit land mentioned in para-3 of the present application.

3) The Ld. Advocate for the respondent (Original defendant) has objected the present application filed by the applicant.

4) Considering the kind of issue in this matter, I found that latest position and exact location/map of the land in question will help this court to serve justice to the parties of the suit and therefor, to get the real position of the subject matter on record and to get judicious end of the matter on hand, hence, in larger interest of justice, I pass the following order:

-: O R D E R :-

- 1) This application is hereby allowed.
- 2) The District Inspector Land Record, Halvad is hereby appointed as court commissioner. He is directed to record panchnama of prevailing situation of disputed land i.e. land bearing land having Revenue Survey No. 92 paiki 714,2-32-70 prati are, Revenue Survey No. 95 paiki 1 khata no. 715,2-32-74 prati are, Revenue Survey No. 95 paiki/2 paiki khata no. 716,2-36-74 prati are situated at Village:Ratabhe, Ta.Halvad District. Morbi and to draw the map showing the exact location of the disputed

land with description after giving notice to the parties and panchas well in advance and shall produce his report on or before **30/03/2026**.

- 3)** The present applicant (Original plaintiff) are hereby directed to deposit Rs.10,000/- (Rupees Ten Thousand Rupees Only) as the remuneration of the court commissioner.
- 4)** Court commissioner letter be issued on deposit of the commissioner fees as per rule.
