**BEFORE THE MOTOR ACCIDENT CLAIMS
TRIBUNAL (MAIN) AT PORBANDAR.**

ORDER BELOW EXH.1 IN MACP NO.2/2025

The applicant is father and next friend of minor who sustained injury in vehicular accident and the applicant was permitted to settle the claim on behalf of minor vide order passed below Exhibit-31. The applicant and opponent No.3 Go Digit General Insurance Co. Ltd. have submitted the settlement memo which is taken on record vide Exh.32. It is stated by the parties by way of this settlement memo that they have arrived at a settlement and the applicant is ready to accept an amount of Rs.3,50,000/- (Rupees Three Lakhs And Fifty Thousand Only) including amount of medical bills of Rs.1,75,000/- (Rupees One Lakh and Seventy Five Thousand Only) as compensation amount towards full and final settlement of the claim. The other terms and conditions have been mentioned in the settlement memo.

This Court is also satisfied that it is just and sufficient compensation and in the interest of the applicant. Hence, I pass the following order:

:: ORDER ::

- [1] The present MACP No.2/2025 is hereby disposed off in terms of the settlement memo (Exh.32) today in National Lok Adalat.
- [2] The opponent No.3 Go Digit General Insurance Co. Ltd. is hereby ordered to deposit an amount of Rs.3,50,000/- (Rupees Three Lakhs And Fifty Thousand Only) towards the final compensation in this petition as specified in the settlement memo, within a period of three months. The

applicant waives his claim for the rest of the claimed amount and also waives the claim against the other opponents.

- [3] As the matter is settled in National Lok Adalat, the office is hereby directed not to deduct or recover the amount of Court fees and if the same has already been paid then to issue a refund certificate in favour of the applicant.
- [4] In view of the directions given by the **Hon'ble Apex Court in the case of Bajaj Allianz General Insurance Co. Ltd. Versus Union of India & Others in Writ Petition (Civil) No.534/2020 dated 16.03.2021 and 16.11.2011**, the opponent no.3 is hereby directed to deposit the above amount into the bank account maintained by this Tribunal through RTGS or NEFT mode within 3 months, and after depositing the compensation amount, insurance company shall communicate the factum of deposit forthwith / expeditiously to this Tribunal via e-mail with a copy to the beneficiary.

- [5] Since the victim applicant is minor, the amount of medical bills being Rs. 175,000/- is ordered to be paid to the applicant through online payment mode RTGS/NEFT. The

remaining amount of Rs.1,75,000/- is ordered to be kept in a fixed deposit in any Nationalized bank in the name of minor through his father and natural guardian namely Devjibhai Virambhai Chudasama for a period of five years or till the minor attains the age of majority, whichever be later. The accrued interest of Fixed Deposit shall be paid to the natural guardian and father of the minor applicant if so desired. The applicant shall not be entitled either to encash the same premature or any loan shall be made available on the same investment without prior permission of the Tribunal. Upon maturity of the fixed deposit amount, the entire amount invested as Fixed Deposit is required to be paid to the concerned applicant after due identification / verification by the concerned bank.

- [6] In view of the judgment of Hon'ble High Court of Gujarat given in a case of **Hansagauri Prafulchandra Ladhani**, reported in 2007 ACJ, 1897 and guidelines given in Special Civil Application No.4800 of 2021 in the case of the **Oriental Insurance Company Ltd. Vs. Chief Commissioner of Income Tax** decided on 05/04/2022, no Tax will be deducted from the amount of compensation awarded by this Tribunal.

- [7] Award to be drawn accordingly.
