Plaintiff filed this suit against defendant for recovery of Rs.2,37,660/- being the principal and interest due under two promissory notes that is Rs.90,000/- dated 10.07.2020 and Rs.80,000/- dated 10.07.2020 and for subsequent interest and Costs of the Suit.

Plaint presented on 07.03.2022

Plaint registered on 22.03.2022

Valuation and Court Fee:

Valuation of the suit for the purpose of court fee and jurisdiction is Rs.2,37,660/-, on which a court fee of Rs.7,352/- is paid under Section 20 of APCF and SV Act 1956.

Cause of action arose on 10.07.2020 and 10.07.2020 when the defendant has borrowed an amounts of Rs.90,000/- and 80,000/- from the plaintiff for his family expenses and executed the suit promissory notes two in number in favour of the plaintiff agreeing to repay the same together with interest at the rate of 24 % per annum; when the defendant has failed to clear off the same; when the plaintiff got issued legal notice to the defendant on 14.02.2022; are within the jurisdiction of this Court.

This suit, has come before me on 06.05.2022 for final hearing in the presence of Sri I.Hanumantha Rao and Sri R.Hazarathaiah, Advocates for the plaintiff and of the defendant is remained set exparte for his non appearance and upon hearing the counsel for the

plaintiff and upon perusing the entire material available on record and having been stood over for consideration till this day, this Court **doth order and decree** as follows :-

01. that the defendant be and hereby directed to pay the plaintiff a sum of **Rs.2,37,660/- (Rupees Two lakhs thirty seven thousands six hundreds and sixty only)** with subsequent interest at the rate of 12% per annum from the date of filing of the suit that is on 07.03.2022 till the date of decree that is on 06.05.2022 and thereafter with future interest at the rate of 6% per annum from the date of decree till the date of realization on the principal sum of Rs.90,000/- dated 10.07.2020 and Rs.80,000/- dated 10.07.2020; and
02. that the defendant do also pay to the Plaintiff a sum of Rs.12,009/- being costs of the Suit.
