:: ORDER ::

(1) The Opponent insurance company(HDFC ERGO GENERAL INSURANCE CO. LTD) is ordered to pay an amount of **Rs.2,50,000/-** (Two Fifty Thousand only) towards the final compensation of this petition to the claimant.

(2) Out of the aforesaid awarded amount firstly to deduct interim compensation amount, if paid.

(3) The opponents shall follow the guidelines of Hon'ble High Court in R/Special Civil Application No.4800 of 2021 in case of The Oriental Insurance Co. Ltd., V/s Chief Commissioner of Income Tax(TDS), decided on 05-04-2022, with regard to the income tax liability.

(4) The Insurance Company is directed deposit the Award amount as per the direction given by the Hon'ble Supreme Court of India in Writ Petition(s) Civil No.534/2020 through RTGS or NEFT mode in the account of Additional District Judge Court, Jetpur the details of account are as under:
