CLAIM PETITION U/S.164 OF M.V. ACT FOR COMPENSATION OF RS. 2,50,000/-

:-ORDER BELOW EXH.01:-

The Claimant and Opponent No.2 – Bajaj General Insurance Ltd., have submitted a settlement pursis vide Exh.-10 regarding the settlement of the claim for **Rs.2,25,000/- (Rupees Two Lakh Twenty-Five Thousand Only)** as full and final settlement, and the same has been voluntarily accepted. This tribunal also deems it to be just compensation. Hence, the following order is being passed:-

::FINAL ORDER::

1.This petition stands disposed of accordingly in accordance with the settlement pursis. The Opponent No. 2 – Bajaj General Insurance Co. Ltd., is hereby ordered to pay an amount of **Rs.2,25,000/- (Rupees Two Lakh Twenty-Five Thousand Only)** towards the final compensation of this petition to the claimant as specified in the terms and conditions of the settlement pursis at Exh.10.

2.If any amount has been paid towards the interim compensation, the same shall be adjusted from the final amount of the aforesaid compensation.

3.The matter is compromised in National Lok-Adalat, so it is hereby directed that neither court fees shall be deducted nor be recovered. Furthermore, the refund certificate of the Court fees shall be issued in the name of the applicant, if court fees have already been paid by the applicant.

4.After deposit of the amount by the Opponent / Insurance Company, in view of the pursis at Exh.10, the entire amount of compensation shall be paid in cash to the claimant by account payee cheque after due verification and identification.
