ORDER BELOW EXH. 1

The applicants have preferred the present application for withdrawal of the amount of order/award deposited by the opponent before the Tribunal as per order passed by the Honourable High Court of Gujarat.

Mr Nazir, District Court has made an endorsement that an amount of **Rs. 6,43,059=00 (Rupees Six Lac Forty Three Thousand Fifty Nine only)** is deposited by the opponent in the Tribunal in MACP bearing No. 886/2011 which is kept in FDR as per order in Dena Gujarat Gramin Bank, Nava Branch, vide "Safe Custody" Register FDR Entry No. 71/2015 To 74/2015.

Being aggrieved and dissatisfied with the award being dated. 10/10/2013 passed by the Tribunal, the Opponent/ Insurance Co. has preferred R/First Appeal No. 387 of 2014 before Hon'ble High Court of Gujarat, in which the Hon'ble High Court has passed an Oral Order being dated. 27/02/2026, whereby the Hon'ble High Court has dismissed the aforesaid appeal and directed as follows :

" The entire award amount be disbursed and released in favour of claimant/s after due verification by transferring said amount/s to the account/s of claimant/s by RTGS or NEFT."

Applicant No. 4 by name Surabhai alias Hurabhai Chunabhai Vadi has died on 29th October 2020. On his having died, his legal heirs have made available the peedigree in support of this fact vide mark - 4/1, The legal heirs have as well made available the consent agreement vide mark-4/2 that they do not have any objection if his share is given to the present applicant No. 1.

Ld. Advocate for applicant has submitted that, applicant No. 2 has attained majority. In support of this fact, he has made available the copy of his school leaving certificate vide mark-3/9.

The Learned advocate for the opponent insurance company has endorsed on application that no objection for disbursement as per order passed by the Honourable High Court of Gujarat.

Hence, Nazir, District Court, Himmatnagar is hereby directed to hand over the aforesaid FDR to the applicants as per order passed by the Hon'ble High Court of Gujarat.

Thereafter, the concerned Bank is hereby directed to pay the amount of the aforesaid FDR to the applicants herein as per order passed by the Hon'ble High Court of Gujarat.

Perused the order/award in view of the above the following order is passed for payment to the applicants as per order passed by the Hon'ble High Court of Gujarat.
