ORDER

1. Read the application & perused the case record available.
2. The Ld. Advocate for the party depositing the compensation i.e. insurance company, has made an endorsement and declared that the Opponent has no objection, if deposited amount may be disbursed to the claimant and also read the endorsement made by Nazir, District Court, Himmatnagar.
3. As per endorsement made below Ex-1 by Nazir, District Court, Himmatnagar, the opponent Insurance company has deposited **Rs. 20,00,000/-** in the court vide Spl. Civil C Regi. FD No.282/2025 in Canara Bank, Himmatnagar.

4. This court is of the opinion that from the amount deposited the amount for deficit Court Fees should be deducted first and remaining amount should be disbursed, would serve the purpose of justice. Hence, the deposited amount i.e. **20,00,000/-** is hereby ordered to be disbursed as under:-

NIL	To be deducted and credited to the Govt. on account of recovered deficit Court Fees & Process fees.
<u>20,00,000/-</u>	To be distributed among the claimant
4,80,000/-	Meghaben Wd/o Pragneshkumar Mangalbhai Suthar: <u>60%</u> Amount to be deposited with nationalized bank for the term of 5 (five) Years, in the name of the Applicant.
3,20,000/-	<u>40%</u> Amount to be paid to the Applicant Meghaben Wd/o Pragneshkumar Mangalbhai Suthar, through RTGS/NEFT, after proper verification and identification.
4,80,000/-	Mangalbhai Chimanlal Suthar: <u>60%</u> Amount to be deposited with nationalized bank for the term of 5 (five) Years, in the name of the Applicant.
3,20,000/-	<u>40%</u> Amount to be paid to the Applicant Mangalbhai Chimanlal Suthar, through RTGS/NEFT, after proper verification and identification.
1,20,000/-	Kinjalben D/o Mangalbhai Chimanlal Suthar , W/o. Bhavinkumar Suthar: <u>60%</u> Amount to be deposited with nationalized bank for the term of 5 (five) Years, in the name of the Applicant.
80,000/-	<u>40%</u> Amount to be paid to the Applicant Kinjalben D/o Mangalbhai Chimanlal Suthar , W/o. Bhavinkumar Suthar, through RTGS/NEFT, after proper verification and identification.
1,20,000/-	Sweetiben D/o Mangalbhai Chimanlal Suthar , W/o. Sanketkumar Suthar: <u>60%</u> Amount to be deposited with nationalized bank for the term of 5 (five) Years, in the name of the Applicant.
80,000/-	<u>40%</u> Amount to be paid to the Applicant Sweetiben D/o Mangalbhai Chimanlal Suthar , W/o. Sanketkumar Suthar, through RTGS/NEFT, after proper verification and identification.
<u>20,00,000/-</u>	Total

5. The said investment shall carry the following terms and conditions:

- (1). Interest accrued periodically on the FDR be credited and paid in the account of the applicant.
- (2). Without prior approval of this tribunal, no loan, overdraft, advance, any type of encumbrance or premature withdrawal shall be made available on said fixed deposit.
- (3). The bank shall intimate to this Tribunal the particulars of the fixed deposited along with a copy of such FDR.
- (4). Upon maturity of such FDR, the principal amount + interest accrued thereon (if any), shall be paid, by A/c payee cheque to the claimant.

Hence, this application is disposed of accordingly.
