ORDER BELOW EXH. 1

The applicants have preferred the present application for withdrawal of the amount of order/award deposited by the opponent before the Tribunal as per order of Hon'ble High Court of Gujarat.

Mr Nazir, District Court has made an endorsement that an amount of **Rs.13,17,459=00 (Rupees Thirteen Lacs Seventeen Thousand Four Hundred Fifty Nine only)** is deposited by the opponent in the Tribunal in MACP bearing No. 481/2014 which is kept in FDR as per order in Canara Bank, Himmatnagar Branch vide "Spl. Civil-C" Register FDR Entry bearing No. 41/2026.

Being aggrieved and dissatisfied with the award being dated. 31/07/2021 passed by the Tribunal, the applicants have preferred R/First Appeal bearing No. 3881 of 2025 before Hon'ble High Court of Gujarat, in which the Hon'ble High Court has passed an Oral Order being dated. 30/01/2026, whereby the Hon'ble High Court has partly allowed the aforesaid appeal and directed as follows :

" Upon depositing of the said amount, the learned Tribunal shall disburse the amount to the original claimants after deducting the court fees, if any, after due verification."

The applicants have further submitted that, the original applicant No. 1 herein by name Rahematben Kadarbhai Mansuri has died on 29th December, 2023. The legal heirs of the aforesaid applicant No. 1 have filed their affidavits vide Exhibit 5 and 7 as well as they have rendered their joint consent to the effect that they do not have any objection if the amount coming to share of the applicant No. 1 be given to the present applicants No. 2 and 3.

The Dy. Registrar, MACT Branch has made an endorsement that no appeal and proceedings are pending in the Honourable Appellate Court now.

The learned advocate for the opponent / Insurance Co. has submitted a no objection pursis as regards disbursement as per order of Hon'ble High Court of Gujarat.

Hence, the amount of the compensation is to be disbursed amongst the present applicant No. 2 and applicant No. 3, in ratio of 50:50.

Hence, Mr Nazir, District Court, Himmatnagar is hereby directed to hand over the aforesaid FDR to the applicants as per order passed by the Hon'ble High Court of Gujarat.

Thereafter, the concerned Bank is hereby directed to pay the amount of the aforesaid FDR to the applicants herein as per order passed by the Hon'ble High Court of Gujarat.

Perused the order/award of Hon'ble High Court and in view of the above, the following order is passed as regards payment to the applicants herein.
