Commitment Order

1 The above named accused have been sent up by the Station House Officer of Police Station 'A' Division, Amritsar to face trial for the offence under Section 379B/411/34 IPC.

2 The facts of the case, in brief, are that present case has been got

registered on written complaint of Ashok Kumar son of Ram Kuber, on the allegations that on 27.11.2019 at about 06.00 PM, complainant was present in street Tehsilpura, backside Pingalwara. Three youth came on a Pulsar motorcycle and snatched his mobile phone Samsung-J-7 bearing Sim card, on which complainant raised raula and followed the motorcycle. The motorcycle slipped away due to its over speed and in the meantime complainant reached there and when they tried to ran away from the spot, complainant caught one person, while the other two persons succeeded to run away from the spot alongwith motorcycle. People gathered at the spot. On asking, said person disclosed his name as Prince alias Mota and he also disclosed the names of other two persons as Sajan and Ghula, who ran away from the spot. Prince was handed over to police. On the basis of statement of complainant, investigation of the present case was started and spot inspection was conducted. FIR Under Section 379-B was registered. During investigation, accused were arrested and they suffered their disclosure statements. The snatched mobile was recovered from the accused. On completion of the investigation, challan was presented against the accused in the court.

3 On appearance before court, accused were supplied copies of documents relied upon by the prosecution as per Section 207 Cr.P.C.

4 The offence under Section **379B IPC** under which the accused

have been booked is exclusively triable by the Court of Sessions. Hence, the present case is committed to the Learned Court of Sessions, Amritsar, for trial. Accused, on bail, are directed to appear before the Court of Learned Sessions Judge, Amritsar on 08.03.2021 at 09.30 A.M. sharp. The order of commitment stands notified to the Learned Public Prosecutor as the order of commitment is pronounced in the presence of Learned Additional Public Prosecutor for the State. Separate notification be also sent to the Learned Public Prosecutor about the commitment of the case. Ahlmad is directed to send the case file complete in all respect to the learned Court well within the date fixed.
