Application For Transfer of Cases u/S 448 of B.N.S.S.

:: ORDER ::

- [1] The present application has been preferred by the applicant praying, *inter alia*, transfer of Criminal Case No. 27961/2007 and Criminal Case No. 31546/2008, pending in two different courts to any of the Courts, as both the cases are arising out of the same offence.
- [2] Ld. APP Mr./Ms. R. P. Dobariya has appeared on behalf of Opponent- State and Ld. Advocate Mr./Ms. M. D. Jhaveri has appeared for Opponent No. 7. They have made an endorsement and given their consent for above referred transfer. The opponent Nos. 2, 3, 4, 5 & 6 have also remained present and made an endorsement and given their consent for above referred transfer.
- [3] Considering above, it appears that both the Cases are pending in connection with the same offence registered with Umra Police Station, Surat vide C.R. No. 322/2007 and Criminal Case No. 31546/2008 is the supplementary charge-sheet of Criminal Case No. 27961/2007, therefore, in order to avoid conflict of decision and multiplicity of the proceedings, it is apt to transfer the proceedings in the same Court, hence, this

application deserves consideration. Accordingly, following order is passed:

:: O R D E R ::

1. The present application stands **allowed**.
2. Criminal Case No. 31546/2008, pending in the Court of 12th Add. Sr. Civil Judge & ACJM, Surat, is hereby ordered to be withdrawn and transferred to the Court of 13th Add. Sr. Civil Judge & ACJM, Surat, wherein, Criminal Case No. 27961/2007, is pending for trial in accordance with the provisions of the law.
3. Yadi of this order be sent to the concerned Courts to proceed further in accordance with law.
