offence	:	U/Ss.188, 270, 271, 149 of IPC and S.51(b) of Disaster Management Act.
Plea	:	Guilty
Finding	:	Guilty
Sentence or Order	:	A1 to A22 are sentenced to pay a fine of Rs. 500/- each. And in default, simple imprisonment for 2 days each.

This case coming on for hearing today, the court passed the following:-

JUDGMENT

1. This is a case chargesheeted by the Sub Inspector of Police, Thodupuzha police station in Cr.No.422/2020 against the accused for the offence punishable u/Ss.188, 270, 271, 149 of IPC and S.51(b) of Disaster Management Act.

2. Copies served. Accused are pleaded guilty. Plea being voluntary, it is accepted.

The accused are found guilty and convicted and sentenced to pay fine of Rs. 500/- each and in default of payment of fine to undergo simple imprisonment for a period of 2 days each.
