Other accused persons are absent with steps (Ptn. No.1959/26 to Ptn. No.1992/26 and Ptn. No.1997/26).

Today, the I.O. has forwarded the Self Contained Note (SCN) prepared by the then I.O. Sri Prateek V. Thube dated 22.06.2024, through letter dtd. 13.07.2026 forwarded by Sri Upen Kalita, APS, Dy. S.P., CID, under memo No. CID/DBR/PS/936/2016/SIT(APSC)/Pt-I/156, as directed by this Court. Keep the copy of the report with the case record properly.

Today, this case was fixed for hearing on consideration of charge. It is submitted on behalf of the Ld. Special P.P. that, as he is out of station, the matter may be heard on a deferred date.

The Ld. Counsels appearing on behalf of accused persons submitted that, since this court has called for a report, which was not forwarded with the charge sheet, copies of that report may be furnished to accused persons.

Earlier, this Court on 25.6.26, has called for a Self Contained Report dated 22.06.2024 in pursuance to filing of a petition by accused Nandini Kakati.

Since, the Self Contained Report was called for by the Court, accused persons will be furnished of the copy of the Self Contained Report dtd. 22.6.2024. Accordingly, soft copies will be provided to them, on or before **06.08.2026**.

Today, through Ptn. No. 1957/26, the accused Bikram Aditya Bora has prayed for discharging of him, from this case. The copy of the petition has been received by the Advocate appearing on behalf of the State.

Through Petn. No. 1956/26, accused Nipon Kr. Pathak has prayed for modification of the bail order dtd. 12.10.2018.

Through, another Petn. No.1955/26, accused Vikash Kr. Pincha prayed that he may be allowed to leave the jurisdiction of this Court w.e.f. 25.7.26 till 19.8.26, enabling him to go to Rajasthan.

It is submitted that conditional bail order was granted earlier in this regard.

Considering the reason specifically mentioned in his petition, the prayer of the accused Vikash Kr. Pincha is allowed.

Through Petn. No. 1995/26, accused Suranjita Hazarika prayed for granting of custody of her seized passport for renewal of it. This petition failed to indicate whether copy of it has been furnished to the opposite party or not.

Through another Petn. No. 1996/26, accused Debojit Bora prayed for granting of custody of his seized passport for renewal of it. This petition failed to indicate whether copy of it has been furnished to the opposite party or not.

Jail authority is directed to produce accused Rakesh Kr. Paul, Samedur Rahman and Basanta Kr. Doley on next date fix.

Issue Production Warrant accordingly.
