

MACMA NO. 37/2026 (In MACP No. 44/2022)
ORDER BELOW EXHIBIT -1

Read the application. Perused the award drawn in MACP No. 44/2022 on dated 13.12.2025 before the MACT(Auxi). Petitioners have prayed to make the payment of amount deposited by the opponent no.3 as per compromise entered between them in National Lok Adalat held on 13.12.2025. 	be made available on the said fixed deposit investment, and the Bank shall not allow any encumbrance on the said fixed deposit without prior permission of this Tribunal.
Rs. 3,13,210/- Rs. 3,13,210/-	Be paid to the claimants as under by way of account payee cheque after due verification and identification. 1) Vasanti Photu Mavli 2) Photu Sarjya Mavli Both Residing at- Khairkhunda Post Umarpata Tal. Sakri, District Dhule, Maharashtra,
Rs.12,52,840/-	Total (Rupees Twelve Lakh Fifty-Two Thousand Eight Hundred forty Only)
