

MACMA NO. 41/2026 (In MACP No. 1/2025)
ORDER BELOW EXHIBIT -1

The application has been read and the award drawn in MACP No.1/2025 dated 13.12.2025 before the MACT (Auxi) has been perused. The petitioners have prayed for payment of the amount deposited by Opponent No.3 as per the compromise entered into between the parties in the National Lok Adalat held on 13.12.2025. It is declared by the petitioners that no appeal has been preferred by any of the parties.

By way of an affidavit, the Claimant has deposed that the names 'Jyotsanaben Narsinhbhai Halpati' and 'Jyotsanaben Anandbhai Halpati' denote the same individual.

As per the endorsement made by the Nazir of this Tribunal, a total amount of Rs.19,00,000/- stands credited in Claim Petition No.1/2025, vide Register C-No.135-2025/26 dated 26/02/2026. The learned advocate Mr.S.K.Desai, representing Opponent No.3, has made an endorsement on the application itself stating that Opponent No.3 – SBI General Insurance Company Limited has no objection if payment is made in accordance with the award. Hence, in the interest of justice, the following order is passed.

ORDER
