ORDER BELOW EXH.1, 199 and 200.

1. The matter is listed today for filing of admission/denial affidavit, as directed vide order dated 02.01.2026.
2. Plaintiff has filed admission/denial of documents filed by defendant nos.1 to 3. However defendant no.1, instead of complying with the order dated 02.01.2026, has filed an application under Section 114 read with Section 151 & 94 of CPC seeking review of order dated 02.01.2026 passed below Exh.166. In response, learned Counsel for plaintiff has requested for time to file reply to the said application.

3. An adjournment application is moved on behalf of defendant no.3 and 4 due to death of a family member of the concerned lawyer hence, the same is granted.
4. Since none has appeared for defendant no.2 as well as there is no compliance of order dated 02.01.2026 by him, his right to file admission/denial affidavit is closed.
5. As regards the application at Exh.199 is concerned, it is to be observed that mere filing of the said application can never be considered as an impediment for not filing admission/denial of the documents produced by plaintiff therefore, defendant no.1 was duty bound to comply with order dated 02.01.2026 moreso, when the Hon'ble Supreme Court vide judgment dated 15.04.2025 passed in SLP Civil No.28062/2024 & 28017/2024 has directed to conclude the trial within one year. Hence, defendant nos.1, 3 and 4 are directed to file admission/denial affidavit on or before next date of hearing, as one last opportunity. With respect to the documents sought to be produced vide application at Exh.199 filed today by defendant no.1, plaintiff may file further additional affidavit of admission/denial, subject to the outcome of this application.
6. Renotify on 20.01.2026 for filing Reply to application at Exh.199 and for compliance of order dated by defendant nos.1, 3 & 4.
