**Application for bail U/s 439 of Code of Criminal Procedure**

Under Sections 457, 380, 411 IPC,  
Police Station Arif Ke.

**ORDER:-**

This order of mine shall decide this application for regular bail under section 439 of Cr.P.C filed in the above noted FIR on behalf of applicant, on the allegations that he is innocent and has been falsely implicated in the present case. Recovery has been planted upon the applicant/accused. He is in custody since 19.07.2023. It will take long time to present the challan and thereafter, in conclusion of trial. No

useful purpose will be served by keeping the accused/applicant in custody. Hence, this bail application.

2. Notice of bail application was issued to State and Sh. Dalip Kumar, Public Prosecutor put in appearance on behalf of State. Record has also been requisitioned.

3. I have heard arguments of learned counsel for applicant and learned Public Prosecutor for State and have gone through the record.

4. As per report of Filing Branch Clerk, no bail application filed by applicant/accused is pending in the Hon'ble High Court. He has attached on record copy of report downloaded from the website of Punjab and Haryana High Court.

5. As per FIR, case was registered on the statement of complainant Kanwaljit Singh son of Shiv Charan Singh that Surjeet Singh son of Joginder Singh has stolen two girders, two machines of hand pump, two angles and other construction material from *Gurudwara Sahib*. At this, a case under section 457, 380 IPC was registered Surjeet Singh and he was arrested on 19.07.2023.

6. Offence is triable by Magistrate. Applicant/accused is in custody since 19.07.2023. It will take sufficient time to present the challan and to conclude the trial. No useful purpose will be served by keeping the applicant behind bars for indefinite period. Present

application for regular bail is allowed. Applicant/accused is admitted to bail on his furnishing bail bonds and surety bonds to the satisfaction of Illaqa Magistrate/Duty Magistrate. Copy of this order be sent to the trial court. Bail papers be consigned to record room.
