ORDER BELOW EXH.1 and Exh.3 IN
SPECIAL ATRO CASE NO.6/2025

APPEARANCE:

Ld. APP for the State.

Accused persons (1) Sunilkumar Naranbhai Rabari, (2) Kaushikkumar Naranbhai Rabari are present with their Ld. Advocate Mr.L.C.Patel.

[1] The present case has arisen from the FIR No.Part-B-11197014251591/2025 registered at P.S. Dabhoi for the offences punishable under sections 115(2), 352, 351(2), 54 of BNS, and sections 3(2)(5-A), 3(1)(R)(S) of Atrocity Act.

[2] After completion of investigation, the charge-sheet was filed against the above accused persons for the offences punishable under sections 115(2), 352, 351(2), 54 of BNS, and sections 3(2)(5-A), 3(1)(R)(S) of Atrocity Act. During the investigation, the accused persons had not been arrested and the charge-sheet has been filed without their arrest. After filing of the charge-sheet, this Court took cognizance against the accused persons and summons were issued. Today, the accused persons - (1) Sunilkumar Naranbhai Rabari and (2) Kaushikkumar Naranbhai Rabari, had appeared before this Court with their Ld. Advocate Mr. L.C.Patel. Ld. APP for the State has sought time to file the documentary evidence list.

[3] As the charge-sheet has been filed against the accused persons without their arrest, Ld. Advocate for the accused persons has moved an application for interim bail at Exh.3 and has submitted that the accused persons had not been arrested

during the investigation and they have appeared before this Court on the summons issued in this case, so there is no apprehension that they may abscond or evade the process of law. It is further submitted by the Ld. Advocate for the accused persons that as the present case falls in the category - 'C' of the judgment of Hon'ble the Apex Court in *Satender Kumar vs. CBI*, so he needs some time to file an application for regular bail and till then, the interim bail may be granted to the accused persons.

[4] The Ld. APP for the State has submitted that the application for interim bail may be decided as per rules.

[5] I have heard the parties and considering the fact that the charge-sheet has been filed against the accused persons without their arrest, and they have appeared before this Court consequent upon the summons issued, the application on interim bail is allowed and the present applicants are directed to furnish the bail bond and surety bond of Rs.5,000/- each before this Court. The interim bail is granted till 07.01.2026 and now the case is fixed for further proceedings on 07.01.2026.
