ORDER BELOW EXH.1 and Exh.5 IN
SPECIAL ATRO CASE NO.8/2025

[1] The present case has arisen from the FIR No.11197008250408/2025 registered at P.S. Chanod for the offences punishable under Section 115(2), 296(kh), 351(2) of BNS and Section 3(1)(r), 3(1)(s), 3(2)(5-a) of the Scheduled Caste and Scheduled Tribe (Prevention of Atrocities) Act, 1989.

[2] After completion of investigation, the charge-sheet was filed against the above accused for the offences punishable under Section 115(2), 296(kh), 351(2) of BNS and Section 3(1)(r), 3(1)(s), 3(2)(5-a) of the Scheduled Caste and Scheduled Tribe (Prevention of Atrocities) Act, 1989. During the investigation, the accused had not been arrested and the charge-sheet has been filed without his arrest. After filing of the charge-sheet, this Court took cognizance against the accused and summon was issued. Today, the accused - Gaurang Harjibhai Rajgor had appeared before this Court with their Ld. Advocate Mr. D.C.Joshi. Ld. APP for the State has sought time to file the documentary evidence list.

[3] As the charge-sheet has been filed against the accused without his arrest, Ld. Advocate for the accused has moved an application for interim bail at Exh.5 and has submitted that the accused had not been arrested during the investigation and he has appeared before this Court on the summon issued in this case, so there is

no apprehension that he may abscond or evade the process of law. It is further submitted by the Ld. Advocate for the accused that as the present case falls in the category - 'C' of the judgment of Hon'ble the Apex Court in *Satender Kumar vs. CBI*, so he needs some time to file an application for regular bail and till then, the interim bail may be granted to the accused.

[4] The Ld. APP for the State has submitted that the application for interim bail may be decided as per rules.

[5] I have heard the parties and considering the fact that the charge-sheet has been filed against the accused without his arrest, and he has appeared before this Court consequent upon the summon issued, the application on interim bail is allowed and the present applicant is directed to furnish the bail bond and surety bond of Rs.10,000/- before this Court. The interim bail is granted till 18.02.2026 and now the case is fixed for further proceedings on 18.02.2026.
