	17.04.2026	<p>A petition for bail vide MCA No. <b>1992/2026</b> filed on behalf of petitioner/accused namely <b>Rakesh Kumar Bari @ Rakesh Ram Bari (who is in custody since 08.04.2026)</b> in connection with <b>Chutia PS Case no. 42/2026</b> registered u/s 318(4) of BNS and Section 63/65 of Copy Right Act and Section 103/104 Trade Mark Act. Copy of petition has already been supplied to Ld. APP.</p> <p>Learned counsel appearing on behalf of the accused/petitioner has submitted that the petitioner is quite innocent and has committed no offence as alleged and he has been falsely implicated in this case. There is no independent witness to the alleged recovery and at this stage there is no credible evidence to link the petitioner with the offence and false recovery of HP Toner and cartridge has been shown from the apartment which does not belong to the petitioner. Further submitted that consent of Registrar of Trade Marks has not been obtained as prescribed under section 15 of Trade Marks Act. Petitioner is in custody since 08.04.2026 and he has no criminal antecedent and ready to furnish sufficient sureties to the satisfaction of this Court. Hence, it is prayed to enlarge the petitioner on bail.</p> <p>Learned A. P. P. appearing on behalf of State has vehemently opposed the prayer for bail.</p> <p>Having heard both the sides and perused the case record, it appears that the brief facts appears from written report of informant Raj Kumar who is Research Officer in Icon Outsourcing Pvt. Ltd, New Delhi 110034 wherein it is alleged that he got secret information that counterfeit toner/ ink cartridge of H.P. company are being manufactured and stored in the flat and sold in various cities by showing them as original. Accordingly, on the basis of such information the informant raided the said flat and huge quantity of counterfeit toner/ ink cartridge etc of HP company have been</p>

Hence, the present case has been lodged.	<p>During the course of hearing of bail matter criminal antecedent of accused/petitioner was called for and the same has been received which shows that the petitioner/ accused has no criminal antecedent. The petitioner is simply staff at the place where recovery of counterfeit HP toner/ cartridge was made. This accused/petitioner was remanded in this case on <b>08.04.2026</b> to B.M.C. Jail, Hotwar, Ranchi and <b><u>since then he is behind the bar.</u></b></p> <p>Considering the aforesaid facts as well as submissions so advanced by the Ld. counsel appearing for the accused/petitioner as well as considering the gravity of the offence coupled with period of detention, the accused/petitioner namely <b>Rakesh Kumar Bari @ Rakesh Ram Bari</b> is hereby <b><i>enlarged on bail</i></b> on furnishing bail bond of <b>Rs.20,000/- with two sureties of the like amount each. The bailors must be the local resident of Ranchi with condition that he will not indulged himself for same and similar offence, will cooperate in investigation as and when required and <u>he will submit his mobile number at the time of furnishing of bail bonds, will not change his mobile number without prior permission of the Court.</u></b> Accordingly, this Misc.
