PLAINTIFF:

I know Sri. Srinath Plaintiff No. 1 herein since from 2013. Witness verify the agreement of sale EX P12, witness identifies his signature in EX P 12. it is marked as EX P 12(a). Identify another signature as the signature of Girija's husband Shashi Kumar is marked as EX P 12(b) . (At this stage counsel for Defendant objected that the signature of the Shashi kumar should be marked by Shashi Kumar himself , for that Plaintiff counsel submit and witness submits that he was also present at the time of executing EX P 12. Hence objections over ruled).

Identify Girija's Signature on EX P 12 which is marked as EX P12 (c) (At this stage counsel for Defendant objected that the signature of the Girija should be marked by Girija herself , for that Plaintiff counsel submit and witness submits that he was also present at the time of executing EX P 12. Hence objections over ruled).

Identifies Builder Partners signatures on EX P 12 of Chennam Ranga Swamy marked as EX P 12(d) and Vishwas Signature as EX P12(e) also identifies signature of purchasers D. Srinath Reddy as EX P 12(f) and his wife Parimala .B. as EX P12(g) . (At this stage counsel for Defendant objected that Plaintiff himself examined as PW1 and not identify these signature, these signatures are identified by witness).

Witness identifies EX P 22 and his signature which is marked as EX P 22(a) . identify another signature stating as one person from builders office by name Raja Shekar .B marked as EX P 22(b). (At this stage counsel for Defendant objected that the signature of the Raja Shekar .B should be marked by Raja Shekar .B himrself , for that Plaintiff counsel

submit and witness submits that he was also present at the time of executing EX P 22. Hence objections over ruled).

Identify Girija's signature as which is marked as EX P 22(c) , purchasers Srinath Reddy and Parimala signature as EX P22(d) and EX P 22(e). Builder partners signature as Chennam Ranga Swamy as EX P22(f) and Vishwas signature as EX P22(g). EX P22 document is executed in the Bank. By the time I signed to EX P 22 all these persons are present along with Raja Shekar and Bank Manager.
