EXAMINATION-IN-CHIEF

On 01.04.2024 I was posted at Dharmanagar District Hospital Emergency. On that day, Md. Chhad Uddin, Mst. Ayasha Begam and Md. Jakir Ahamed came to the hospital and I examined them and prepared the report. On examination of Md. Chhad Uddin who came with alleged history of assault I found pain over back side of chest/abdomen. As such no external injury was found and the injury was simple in nature caused by blunt object. This is the report prepared by me bearing my seal and signature identified and marked as **Ext.4** and my signatures **Ext. 4/1 (series)**.

On examination of Mst. Ayasha Begam who came with alleged history of assault I found chest pain and back pain and no external injury was found. The injury was simple in nature caused by

blunt trauma. This is the report prepared by me bearing my seal and signature identified and marked as **Ext.5** and my signatures **Ext. 5/1 (series)**.

On examination of Md. Jakir Ahamed who came with alleged history of assault I found lacerated wound over head. The injury was simple in nature caused by blunt object. This is the report prepared by me bearing my seal and signature identified and marked as **Ext.6** and my signatures **Ext. 6/1 (series)**.

CROSS-EXAMINATION

It is not mentioned in my report that Chhad Uddin, Ayasha Begam and Jakir Ahamed were brought to the hospital by fire service. They came by themselves. The pain reported with respect to Chhad Uddin and Ayasha Begam was as per their narration. I did not mention the age of injury sustained by Jakir Ahamed in my report. I did not receive any requisition from police on 01.04.2024. My emergency duty is from morning 09.00 am to 03.00 pm. There are other officers as well along with me on emergency duty. The emergency register number is not MLC. I did not mention the MLC register number in my reports. I did not give my final opinion with regard to the injury sustain by Jakir Ahamed after consultation with general surgeon. The injury sustained by Jakir Ahamed can occur from sudden fall.

It is not a fact that Chhad Uddin, Ayasha Begam and Jakir Ahamed did not visit District Hospital or I did not examine them on that day.
