EXAMINATION IN CHIEF

The complainant of this case is my father. On 01.04.2024 at around 12.30 noon after I came back from the school I saw that my uncle Samas Uddin and my aunty Lila Begam were assaulting my father and mother in our Agar Garden by means of dao and lathi. Samas Uddin assaulted my father by lathi and Lila Begam inflicted dao blow on my mother. They also assaulted my sister and brother. My mother was taken to the hospital through Fire service. Witness identified the accused in the dock.

CROSS-EXAMINATION

I read in Krishnapur School which is half and hour walking distance from my house. My school starts from 10.00 am in the morning. Near our house there are the houses of Sab Uddin, Alim Uddin and Abdul Mallik. My brother Bariul Ahamed read in class-VII in Lathugao School and the school is at a distance of 10 minutes from our house. On 01.04.2024 I had gone to the school. Our school get over at 04.00 pm. The Agar garden is at a distance of 100 meters from our house. Manik Miah is my grandfather. There is land dispute between my father and grandfather. I am not aware if my grandfather and my uncle had filed any case against my father. In our school attendance registered is maintained.

It is not a fact that on the alleged date and time I did not return from school or that I did not see my uncle and aunty assaulting my father and mother by means of dao and lathi or that Lila Begam did not inflict dao blow on my mother or that Samas Uddin did not assault my father by lathi or that my mother not taken to hospital.

I was examined by IO on 08.04.2024.

It is not a fact that I did not mention before IO that I had returned from school (**subject to confirmation by the IO**).

It is not a fact that to save my father from the allegations of the case filed by my uncle and grandfather I have deposed falsely today as being tutored by me parents.

EXAMINATION-IN-CHIEF

The complainant of this case is my father. The incident took place on 01.04.2024 at around 12.00 noon. I was in my house when hearing hue and cry coming from the Agar garden I came out and saw that Samas Uddin and Lila Begam were assaulting and Samas Uddin had lathi in his hand and Lila Begam had dao. Lila Begam wanted to inflict dao blow on my father but it fell on the finger and head of my mother and she lost her consciousness. Samas Uddin tore the nighty of my mother. Witness identified the accused person in the dock.

CROSS-EXAMINATION

The house of Chayna Begam is at a walking distance of five minutes from my house. On 01.04.2024 I had gone to my school. Its starts at 07.00 am in the morning and gets over by 10/10.30 am. The agar garden is at a distance of 50 to 60 meters from my house. I am not aware about any land dispute between my father and my grandfather and uncle. Ramina Begam is my aunty (pishi) and her house is at a distance of 02 minutes walking from my house.

It is not a fact that I did not come out hearing hue and cry or that I did not see Samas Uddin and Lila Begam assaulting my parents or that I did not see Lila Begam inflicting blow on my father which fell on the finger and head of my mother or that Samas Uddin did not tear the nighty of my mother. It is not a fact that I am deposing falsely being tutored by my parents.

CROSS-EXAMINATION

I was examined by the IO in connection with this case.

It is not a fact that I did not state before IO that I suddenly heard some hue and cry and on reaching the spot I found Samas Uddin holding the Mina Begam from her hair and tore her wearing nighty **(subject to confirmation by the IO)**.

It is not a fact that this is my first time statement before the court.

We are three brothers and five sisters. We have no land dispute between our brothers and sisters. Ramina Begam is my niece. There are 08 to 10 houses in between my house and the house of Chhad Uddin. I cannot say if my brother Manik Miah and his son Samas Uddin had filed any case against Chhad Uddin. I have not received any share in my ancestral

property. The ancestral property is not yet partitioned. We have also not raised any claim for the property.

It is not a fact that I am deposing falsely as per advice of Chhad Uddin to save him from the liability of the other case.
