Further Cross Examination by advocate for Claimant no.2.

I studied upto 4th standard. I have given instructions to my advocate to prepare my evidence affidavit. It is true that the documents at Ex.P.1 to 12 are given by me to my advocate. I had the knowledge of said documents. I do not know when my mother purchased the property involved in this case. I do not know when I have born or not when the property has been purchased. I do not know the contents of sale deed produced by me. I do not know that the vendors of my mother in the sale deed dated 25-06-1973 claimed that they are not the owners, but they were in possession of the property. I do not know when the purchased property changed to the name of my mother. I know only about the acquisition of property by the respondent and we entitled for compensation. I do not know the date in which respondents have taken possession of the property. It is true that as per Gazette notification, KHB has taken the possession of property as on 12-11-2012. It is false to suggest that I have paid the tax as on 18-06-2024. It is false to suggest that the tax paid receipts at Ex.P. 4 had been created by me for the purpose of this case. I do not know that one V. Prabhakar filed a suit against me, my mother and others in O.S. 143/2018 on the file of Civil Judge

Court, Magadi. My mother was an agriculturist. I have produced documents to show that my mother was an agriculturist. It is false to suggest that I have not produced any such documents to show that my mother was an agriculturist. I have not produced any documents to show that I am an agriculturist. I do not know that my sister Parvathi in the affidavit filed in O.S. 143/2018 claimed that her father's name was Revanna. I do not know the said Revanna was the Panchayath Chiarman of Byalalu Village Panchayath. I do not know the said Revanna died about 2 years back. I do not know in order to defraud to claimant no. 2 the then Pachayath President created the documents in favour of my mother in the year 1973 by creating a sale deed dated 25-06-1973 as per Ex.P..1. It is true that as per MR Extract at Ex.P. 2 Kempa Kadaraiah sold the property to Kalingamma bin Kalingaiah. I do not know as per Ex.P. 2 the sale deed referred is dated 28-06-1973. I do not know that name of Kempakadaraiah is not found as a vendor at Ex.P.1. My mother god mutated the property in her name. I have not made any attempt to get the change of khatha in the name of my mother. I do not know whether Kempakadaraiah was alive or not when the mutation

taken place. I have not made any enquiry about the causing of notice to the wife and children of Kempakadaraiah before changing the Khata on the basis of Ex.P.1. My mother was illiterate. It is true that my advocate in this case also appearing on our behalf in O.S. 166/2018. I do not know that my mother filed a written statement in O.S. 166/2018. I do not know that I have produced Ex.P. 8 in this case. I do not know that in the written statement at Ex.P. 8 my mother has taken the contention that Kempakadaraiah and Nagamma died issueless. It is false to suggest that my mother has taken false contention in Ex.P. 8.
