

**Witness present and duly sworn on 08.01.2024**  
**Cross examination by Smt. PSU Advocate for Respondent no.2:-**

It is false to suggest that I was aged 30years at the time of accident. I was alone. I was going from Ring road towards Kalyan nagar. My father is the RC owner of motorcycle bearing no.KA-03-KC-9374. The motorcycle had insurance from ICICI Lombard. I have DL. The accident was not the head on collision. The accident occurred when the car suddenly took right turn without any indication and the car's tale lamp touched my motorcycle's left handle. I didn't inform the police till my treatment was complete.

2. Immediately after the accident I went to Bengaluru North hospital. Either me or my family members didn't inform in the hospital how I sustained injuries. The persons from the car were only with me at the time of admission. From there I was taken to Manipal hospital on the same day. The car driver came to Manipal hospital with me. I took treatment for one day in Manipal hospital. I had explained the history of injury in the Manipal hospital. Ex.P-8 discharge summary is correct. It is false to suggest that according to history of illness mentioned in Ex.P-8, I had sustained injury by falling and that was not correct.

3. It is true that I had sustained injury only to ring finger of my left hand and complaint was given after 16days. We are four persons in the family, my parents and one younger brother of 24years. It is true that either my father or my younger brother had no difficulty to give complaint immediately after the accident. It is true that till 16days no MLC was registered either in North Bengaluru hospital or Manipal hospital. It is false to suggest that we took 16days to implicate the offending car. It is true that MLC is registered on 04.11.2022 on my request. It is true that later on 09.11.2022 we gave complaint.

4. It is false to suggest that for 16 days I didn't inform in the hospital how I sustained injury. For the suggestion that according to Manipal hospital records, it was not the case of RTA, witness says that though we informed that it was due to accident, due to emergency they got admitted me. It is false to suggest that it is not the case of amputation as mentioned in the discharge summary as I have my ring finger now. Witness says that it was totally crushed and it was rejoined. It is false to suggest that it is not the amputation and it is only shortening of ring finger.

5. It is false to suggest that the car bearing no.KA-53-MF-1869 is falsely implicated by colluding with 1<sup>st</sup> Respondent. It is

true that according to my offer letter 15.08.2020, I joined the service from 14.08.2020. It is false to suggest that this offer letter is created only to produce before this court. It is true that there is no received and accepted signature in the offer letter. It is true that my salary is varied from month to month. It is false to suggest that I have not produced any documents to show that I didn't get salary for January, February and March 2023 month salary. It is true that I have received salary in November and December 2022 after the accident but it is earlier month's incentives. I did not have any difficulty to produce endorsement from my employer with regard to not receiving salary. I can produce it. Now I am getting salary of Rs.18,000/- to Rs.20,000/- per month. It is true that I have received gross salary of Rs.38,000/- in June 2023. It is true that I am double the salary now than what I was getting in August 2022.

6. It is true that bill no.19 has been included in IP bill at serial no.1. At the time accident I have no medical insurance facility. I can; produce the endorsement from the employer saying I have not obtained any medical reimbursement. It is false to suggest that as it was not the RTA, for 16 days I didn't inform the hospital that the injury was due to RTA and after

colluding with RC owner, it has been falsely implicated and false complaint is given.
