Cross examination by advocate for Respondent:-

I was proceeding from my work place towards my house. I was riding the motorcycle with one pillion rider Lakkanna. I am the RC owner of the motorcycle. The said motorcycle was insured. I had DL. I can produce RC, policy and DL. It is false to suggest that at the time of accident, the motorcycle was not having valid insurance and I did not possess valid DL, thereby I have not produced the same before this court.

2. While I was taking right turn, the offending vehicle came from behind and collided with my vehicle. The offending vehicle is a Swift Car bearing no.KA-41-N-3286. It is false to suggest that we were traveling three person on the motorcycle, I abruptly took right turn, thereby causing the accident. It is false to suggest that accident did not occur due to negligence on the part of driver of offending vehicle as I alleged, but it was occurred due to my negligence.

3. Immediately I went to Adithya Trauma hospital. I underwent inpatient treatment for a period of 7 days. I did not take treatment in any hospital other than Aditya Trauma hospital. Witness voluntary states that I took follow up treatment in HYGEIA Ayurvedic hospital. Both bones of my right leg sustained fracture and I underwent surgery for said fractures. Once in a 7 days, an one month, a three months & a six months I underwent follow up treatment. Nearly I underwent follow up treatment for six times. Last visit of my follow up treatment was in the Month of April 2025.

4. I took outpatient treatment in HYGEIA Ayurvedic hospital. The doctors of Adithya trauma hospital have not suggested to take treatment in HYGEIA Ayurvedic hospital. It is false to suggest that as per Ex.P-9 at the time of discharge I was in stable condition. Witness voluntary states that the doctors have suggested me to take rest for two years.

5. It is false to suggest that HYGEIA Ayurvedic hospital only prescribed me to take tablets, however, I did not undergo any Panchakarma treatment as I stated. It is true to suggest that after 01.11.2024 I visited to HYGEIA Ayurvedic hospital before giving my evidence. It is true to suggest that in the medical documents, have not been mentioned that I have visited to the hospital for further treatment. Witness states

that they orally suggested me that to visit after two years for removal of implants. It is false to suggest that I have not produced any OPD documents to substantiate that I visited for follow up treatment in the specified dates. It is false to suggest that though I have not produced any documents, I deposed falsehood before this court to that effect.

6. I was an electrician. I was a contractor. It is true to suggest that I have not produced any documents to substantiate that I was an electrician contractor. I do not have any degree or diploma to do electrician work, however, I had 25 years experience. Four people were working under me. It is false to suggest that after discharge from the hospital, I can perform my day to day activities as I did prior to the accident.

7. I was not insured from any health insurance. I can produce documents to substantiate that on 13.04.2024, 02.05.2024, 25.05.2024, 02.07.2024, 20.07.2024, 11.08.2024, 30.08.2024, 19.09.2024, 05.06.2024, 28.01.2025, 14.02.2025, 10.03.2025, 30.03.2025, 21.04.2025, 27.05.2025, 30.05.2025, 30.06.2025, 01.07.2025, 19.07.2025, 22.07.2025, 13.08.2025, 08.08.2025 I visited to the hospital by using ambulance. I know the owner of the ambulance. I can examine him the owner of the ambulance as a witness before this court. It is

false to suggest that in order to get compensation, I have got created ambulance bills for this case.

8. It is false to suggest that I have not produced prescriptions to support my medical bills. It is false to suggest that I have got created handwriting bills for this case in order to get more compensation. It is false to suggest that serial no.2 to 23 are included with final bill. It is false to suggest that I have got created Ex.P-22 for this case.

9. It is false to suggest that the accident occurred due to my negligence, however, I falsely alleged that accident occurred due to negligence on the part of driver of offending vehicle. It is false to suggest that I falsely deposed regarding my avocation and income. It is false to suggest that I deposed falsehood in para-8 of my chief affidavit regarding expenditure towards medical and future medical expenses. It is false to suggest that in order to get compensation, have got created documents and am deposing falsehood before this court by filing this false affidavit.
