**Cross examination by Sri.VRM Advocate for  
Respondent:-**

At the time of accident. I was coming from Malavalli to Bengaluru. I left Malavalli at 10.00a.m. I had been alone to Bengaluru. Offending vehicle was coming from right side of Kumbapura gate. I have not seen the said vehicle before the accident. The rider of offending vehicle supposed take turn to my lane. The offending vehicle dashed my vehicle from behind. My two wheeler sustained damages on entire back side and front headlight, steering and side lights. It is true to suggest that as per Ex.P-9 my two wheeler sustained damages on the front side and offending vehicle also sustained damages on the front side.

2. It is false to suggest that the accident was not caused as I stated in my affidavit and petition. It is false to suggest that myself hit my two wheeler against right side coming offending vehicle and thereby the accident caused. It is false to suggest that accident occurred due to my negligence and not on the part of rider of the offending vehicle. The two persons

were traveling on the offending vehicle. The said persons have not sustained any injuries.

3. The rider of offending vehicle not rendered any medical service to me. It is true to suggest that after thorough investigation the police have filed charge sheet against the rider of the offending vehicle. It is false to suggest that the rider of offending vehicle was not having DL at the time of accident.

4. Initially I went to Ramanagar Govt hospital. Where in I took first aid treatment then I shifted to Mandya District hospital. I was admitted in Mandya District hospital for one day. Thereafter I shifted to DRM Multi Specialty hospital, Mysuru. I took entire treatment in DRM Multi Specialty hospital, Mysuru. I sustained fracture proximal humerus and other injuries. I undergone surgery for fracture proximal humerus. Implants are in situ. It is time for removal.

5. It is true to suggest that I have taken a health insurance from Medi-Assist India TPA Ltd. It is true to suggest that as per Ex.P-15 the health insurance company has paid entire medical expenditure and I paid only Rs.5,000/-. It is false to suggest that I have not spent Rs.3,00,000/- towards medical expenses as stated in my chief affidavit. It is false to suggest that I have recovered from my injuries, I am hale and

health as earlier and I am not suffering any difficulties as stated in para-5 of my chief affidavit.

6. I was born on 08.06.1983. My qualification is ITI. From 18 years, I am working in Peenya Auto CNC Machining Ltd. Presently I am working there. Prior to accident I was getting salary of Rs.72,000/-, now also I am getting Rs.72,000/-. I took two months leave. I have not produced any documents before this court regarding loss of leave. I can produce documents to show the loss of leave. The salary has been credited to my salary account. I can produce my bank statement. It is false to suggest that I am not suffering any financial loss from the accidental injuries as I am continuing the same job. It is false to suggest that in order to get compensation I am deposing falsehood before this court by filing this false affidavit.
